ORDER

Tvl. Lotus Wireless Technologies India Pvt. Ltd., New No.8, Old No.28, Rangarajulu Street, Ayyavu Colony, Aminjikarai, Chennai - 600 029 (TIN:33291484129), the registered dealers in the files of MMDA Colony Assessment Circle have preferred application in Form 'VV' and sought clarification under Section 48-A (1) of the TNVAT Act, 2006, read with Rule 12-A of TNVAT Rules, 2007.

2. The applicant-dealers have sought for clarification on the following:

Sale of Electrical equipments to TANGEDCO through Vendor

- 3.1. The applicant-dealers are supplying materials to TANGEDCO through the main vendor M/s.Ashoka Buildcon Limited (TIN:33811304199). The main vendor M/s.Ashoka Buildcon Limited charging VAT @ 5% to TANGEDCO as per G.O.Ms.No.77, Commercial Taxes and Registration (B2) Department, dated 11.07.2011.
- 3.2. The applicant-dealers have sought for clarification whether TvI. Lotus Wireless Technologies India Pvt. Ltd., Chennai-600 029 are eligible to charge VAT at 5% rate as per G.O.Ms.No.77, Commercial Taxes and Registration (B2) Department, dated 11.07.2011 or at the applicable rate as per the commodity sold.
- 3.3. The issue has been examined in detail with reference to the provisions of the TNVAT Act, 2006 and Rules, 2007; and as per G.O.Ms.No.77, Commercial Taxes and Registration (B2) Department, dated 11.07.2011, the reduced rate of 5% is available to the Vendors who are directly selling goods to TNEB, TANGEDCO, TANTRANSCO, NLC, etc..
- 3.4. In this issue, if the applicant-dealers are selling their goods through vendor, the applicant-dealers are not eligible to avail the reduced rate of tax as per G.O.Ms.No.77, Commercial Taxes and Registration (B2) Department, dated 11.07.2011. The clarification is given accordingly as under.

3.5. The clarification, therefore, is that, for "Sale of Electrical equipments to TANGEDCO through Vendor", the applicantdealers are not eligible to avail the reduced rate of tax at 5% as per G.O.Ms.No.77, Commercial Taxes and Registration (B2) Department, dated 11.07.2011.
