ORDER

1. Tvl. Currimbhoys Marketing Pvt Ltd., Chennai-3 (TIN. No.33780340569), registered dealers in the files of Evening Bazaar Assessment Circle, Chennai have preferred application in Form 'VV'

and sought clarification under Section 48-A (1) of the TNVAT Act, 2006, read with Rule 12-A of TNVAT Rules, 2007.

- 2. The applicant-dealers have sought for clarification on the rate of tax applicable on sale of "Vegetable Choppers".
- 3. This Committee examined the application in detail with reference to the Schedules and provisions of TNVAT Act, 2006 and Rules, 2007. Vegetable choppers would not fall under any specific entry of the Schedules given under TNVAT Act, 2006. Consequently, the goods would fall under the residuary Entry No.69 cf Part-C of First Schedule to TNVAT Act, 2006.
- 4. In view of the above discussion, this Committee clarifies that 'vegetable choppers' dealt by the applicants would fall under Entry No.69 of Part-C of First Schedule to TNVAT Act, 2006, attracting levy of tax at 14.5%.
