## <u>ORDER</u>

Tvl. Tagros Chemicals India Limited, "Jhaver Centre" Rajah Annamalai Building, IV Floor, 72, Marshalls Road, Egmore, Chennai-600 008(TIN No.33360441486), the registered dealers in the files of Egmore – I assessment circle, Chennai, have preferred application in Form "VV" and sought clarification under Section 48-A (1) of the TNVAT Act, 2006, read with Rule 12-A of TNVAT Rules, 2007.

2. The applicant-dealers have sought for clarification on the following:

## Rate of tax on "Sale of Pesticides to formulators who formulated using solvents, Permethrin - Technical"

The applicant dealer in their Form VV have requested to clarify the rate of tax on sale of "Sale of Pesticides to formulators who formulated using solvents, Permethrin - Technical" which are manufactured and sold locally. The applicant dealer has also requested to grant a personal hearing before pronouncing the ruling on the questions raised in this application.

- 3. The issue has been examined in detail with reference to the provisions of TNVAT Act, 2006 and Rules, 2007 as well as relevant entries under entry 38-A (b) in Part-B of the Forth Schedule to the TNVAT Act 2006, and also with reference to the certificate No.CRI-51,540/2005-Permethrin(TIM)(256)-105-F.No.43-TIM/9(4)/2004 issued by the Ministry of Agriculture (Department of Agriculture and Cooperation)/Directorate of Plant Protection, Quarantine & Storage, Faridabad, authorizing the applicant dealer for manufacturing and marketing Insecticides namely "Permethrin" - Technical.
- 4. Examination of the certificates issued by the Central Government authorities revealed that the applicant dealer are authorised for manufacturing and marketing Insecticides namely Permethrin" - Technical. Indigenously manufactured Permethrin -Technical is primarily used as pesticides or insecticides.
- 5. Therefore, it is clarified that "Permethrin"- Technical"-is a species of "Insecticide" for Agricultural/horticultural purposes exempted from tax falling under entry 38-A (b) in Part-B of the Forth Schedule to the TNVAT Act 2006, if used for agriculture/horticulture purposes.
