**PUBLIC NOTICE**  
**FOR OPEN AUCTION OF MOVABLE PROPERTIES UNDER SECTION 67(10) OF TNVAT ACT 2006**  
**READ WITH RULES 15(8)(a), (b), (c) and (d) of TNVAT RULES 2006**

It is hereby notified that the under-mentioned movable properties of Tvl.Sinegam & Co., 41 M Uppu Thottam, 2<sup>nd</sup> Street, Annur 641653 was detained on 11-8-2014 for non-payment tax and penalty by the detention order No.1573/2014-15. The container stuffed with the goods is lying in the **Concor Checkpoint**, Thiruvottiyur, Chennai - 600 019 from 11-08-2014. The above firm preferred a Writ petition in the High Court of Madras against the detention order. The Hon'ble High Court, in WP.No.22209/2014 dated 19-08-2014 ordered to release the goods on payment of one time tax Rs.1,35,000/- (Rupees one lakh thirty five thousand only) and proceed with adjudication process. Since the owner of the goods did not turn up and remit the said sum and subject themselves for adjudication process, the goods stuffed in the 40' feet container has not been released for more than three years. It is decided to dispose of the goods more particularly mentioned in the Schedule by way of open auction under section 67 (10) of TNVAT Act 2006 read with Rules 15(8)(a),(b)(c),and (d) and remit the sale proceeds into government account to adjust against the tax and penalty due by the above said default firm.


2. It is proposed to conduct the open auction at 11-00 am on 29 -05-2018 at the premises of Concor Checkpoint on 'as is where is basis'. Intending bidders shall deposit as **earnest money** a sum of Rs.2000/- (Rupees two thousand only). The auction will be knocked down in favour of the highest bidder subject to the confirmation of sale by the Joint Commissioner(ST), Enforcement-I, Chennai 600 006.

3. The auction purchaser shall pay the sale value of the goods in cash/ or demand draft payable in favour of the undersigned, immediately after the sale and he will not be permitted to carry away any part of the goods until he has paid for the same in full and until the auction sale has been confirmed by the above said higher authority. The earnest money deposited by the unsuccessful bidders shall be refunded to them immediately after the auction is over.

4. The auction purchaser shall, after confirmation of the sale, at his own cost and expense remove immediately the movable property from the premises where the same is stored.
