ORDER:

The Special Commissioner and Commissioner of Commercial Taxes issued circulars - vide L.Dis.43567/90, dated 15.05.1990 and Acts Cell-II/K.Dis.33733/90, dated 15.05.1990 clarifying that the sales of electronic goods in the course of inter-State trade with or without 'C' form attracted liability at 3%. However, it was revised in Acts Cell-III/89631/92, dated 22.10.1992 and clarified that the sales of electronic goods in the course of inter-State trade with or without 'C' form was liable to tax at 10%. Hence, the Joint Commissioners were instructed to send waiver proposal for the period from 15.05.1990 to 22.10.1992, wherever the dealers have not collected tax more than 3%. The proposals received from all the Joint Commissioners were compiled and sent by the Commissioner of Commercial Taxes to the Government and also placed before the Waiver Committee for its decision. The Waiver Committee accepted the proposal and recommended for waiver. Accordingly, in the Government Order first read above, the Government issued orders for waiver of an amount of Rs.9,25,42,826/-(Rupees nine crore twenty-five lakhs forty-two thousand eight hundred and twenty-six only) being the Central Sales Tax arrears in respect of inter-State sale of electronic goods without 'C' form during the period from 15.05.1990 to 22.10.1992.

2. After the issue of the above Government Order, the Joint Commissioner (Commercial Taxes), Chennai (South) Division had sent supplementary waiver proposal in respect of the following four dealers for waiver of arrears of Central Sales Tax on the inter-State sales of electronic goods without "C" form for the period from 15.05.1990 to 22.10.1992, which were not included in the above Government Order:-

Hence the Additional Chief Secretary/Commissioner of Commercial Taxes placed before the Waiver Committee the supplementary waiver proposal for an amount of Rs.73,95,364/- in respect of the abovesaid four dealers in Chennai (South) Division for waiver of arrears of Central Sales Tax on the inter-State sales of electronic goods for the period from 15.05.1990 to 22.10.1992, since the dealers had collected Central Sales Tax only at 3% on the inter-State sales of electronic goods without 'C' form during the above period and not included in the orders issued in the Government Order first read above.

- 3. The Waiver Committee has agreed to the proposal for supplementary waiver of Central Sales Tax on inter-State sale of electronic goods without "C" form during the period from 15.05.1990 to 22.10.1992.
- 4. The Government, after careful examination, have decided to accept the recommendation of the Waiver Committee. Accordingly, in exercise of the powers conferred under item 7 of Appendix 21 of Chapter XII of the Tamil Nadu Financial Code Volume-II, the Government waive an

amount of Rs.73,95,364/- (Rupees seventy-three lakhs ninety-five thousand three hundred and sixty-four only) being the amount payable by the four dealers from Chennai (South) Division under the Central Sales Tax Act, 1956 in respect of inter-State sale of electronic goods without 'C' Form as indicated below for the period from 15.05.1990 to 22.10.1992:-
