ORDER:-

While moving the Demand for Grant relating to Commercial Taxes Department for the year 2016-17, the Hon'ble Minister (Commercial Taxes) has made the following announcement on the floor of the Assembly on 23.8.2016:

''வணிகவரித் துறையில் பயன்படுத்த முடியாத நிலையில் உள்ள பழைய வாகனங்களுக்கு பதிலாக, மாண்புமிகு தமிழ்நாடு முதலமைச்சர் அவர்களின் ஆணைப்படி இவ்வாண்டில் ரூ.35.00 இலட்சம் மதிப்பீட்டில் 5 புதிய வாகனங்கள் வாங்கப்படும். இதனால், வணிக வரித்துறையின் செயல்பாடுகள் தடையில்லாமலும், வரிவசூல் சிறப்பாகவும் நடைபெறும்.''

- In accordance with the above announcement, the Additional Chief Secretary/Commissioner of Commercial Taxes has sent proposal in his letter read above for the purchase of 5 vehicles in lieu of condemnation of equal number of vehicles along with the Certificate obtained from the Director, Tamil Nadu Motor Vehicle Maintenance Department. He has also reported that the Director, Tamil Nadu Motor Vehicle Maintenance Department has stated that no jeeps are available in the common pool of Motor Vehicle Maintenance Department. The Additional Chief Secretary/Commissioner of Commercial Taxes has therefore requested to issue orders for condemnation of 5 vehicles [(1 Mature condemnation of vehicle having Registration No. TN 07 G 1001) and 4 Premature condemnation of vehicles having Registration No.TN 07 G 9666, TN 07 G 8283, TN 07 AG 7070 and TN 07 G 1683)] owned by the office of the Commissioner of Commercial Taxes and accord sanction for purchase of 5 Bolero LX/2WD/7 STR NA BS-IV Jeeps from M/s Mahindra & Mahindra Limited, Chennai at a cost of Rs.32,84,225/- (Rupees Thirty Two lakh eighty four thousand two hundred and twenty five only) for the use of the Office of the Commissioner of commercial Taxes.
- 3. The Government after careful examination of the proposal of the Additional Chief Secretary /Commissioner of Commercial Taxes,

sanction a sum of Rs.29,57,555/- (Rupees Twenty nine lakh fifty seven thousand five hundred and fifty five only) for purchase of 5 new Bolero LX/2WD/7 STR NAC BS-IV PS Jeeps for the use of Office of Commissioner of Commercial Taxes as follows subject to the conditions that (a) separate proposal should be sent to Finance (Home) Department for fuel allotment after purchase of the vehicles and (b) the norms prescribed in G.O.(Ms.) No.1229, Home Dept. dt.21.12.2006 and G.O.(Ms.) No.297, Home Dept. dt.25.2.2008 should be followed:-

4. The amount sanctioned in para 3(iii) above shall be debited to the following head of account:-

"2040-00 Taxes on Sales, Trade etc., - 001 Direction and Administration - I. Non Plan - AA Head Quarters Establishment - 21 Motor Vehicles - 01 Purchase" (DP Code 2040 00 001 AA 2111).

5. The expenditure sanctioned in para 3(iii) above constitutes an item of "New Instrument of Service". The approval of the Legislature will be obtained in due

course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund and orders in this regard will be issued by the Government in Finance (BG-I) Department, separately. The Additional Chief Secretary/Commissioner of Commercial Taxes is requested to send necessary proposals to the Government in Finance (BG-I) Department, in the prescribed format along with a copy of this order indicating the actual amount required upto next Supplementary Estimate for sanction of an advance from the Contingency Fund of the State. He is also requested to send a draft explanatory note, indicating the total cost of the scheme, the cost that would be required for the implementation during the financial year etc., to Government in Finance (BG-I) department for inclusion of the expenditure in the Supplementary Estimate 2016-2017 at an appropriate time.

- The Government also permit the Director, Motor Vehicle Maintenance Department to dispose of the 5 vehicles [(1 Mature condemnation of vehicle Registration No.TN 07 G 1001) and 4 Premature condemnation of vehicles Registration No.TN 07 G 9666, TN 07 G 8283, TN 07 AG 7070 and TN 07 G 1683)] in public auction and to credit the sale proceeds to the Government Account. He is requested to follow the procedures laid down in the Government Orders intended for premature condemnation of vehicles.
- This order issues with the concurrence of Finance Department vide its U.O.No.4312/Finance(Revenue)/2017, dated 07.02.2017 with Additional Sanction Ledger No.2011 (Two thousand and eleven).
