ORDER:-

While moving the Demand for Grant relating to Commercial Taxes Department for the year 2016-17 on the floor of the Assembly on 23.8.2016, the Hon'ble Minister (Commercial Taxes) has made the following announcement:-

“சென்னை கிரீம்ஸ் சாலையில் அமைந்துள்ள வணிகவரி அலுவலக வளாகத்தில் 70 அலுவலகங்கள் இயங்கி வருகின்றன. இந்த அலுவலகங்களுக்கு நாள்தோறும் வணிகப் பெருமக்களும் இதர பார்வையாளர்களும் பெருமளவில் வருகை புரிகின்றனர். எனவே, இவர்களுக்கு பயன்படும் வகையில், சென்னை கிரீம்ஸ் சாலையில் அமைந்துள்ள பேரறிஞர் அண்ணா பவளவிழா நினைவு கட்டடத்தில் (பிரதான கட்டடம்) உள்ள கட்டமைப்பு வசதிகளை மேம்படுத்தும் விதமாக, ஏற்கனவே உள்ள 30 வருட பழமை வாய்ந்த, இயக்க நிலையில் இல்லாத இரண்டு மின்தூக்கிகளை நவீனமயமாக்குவதற்கு, மாண்புமிகு தமிழ்நாடு முதலமைச்சர் இதய தெய்வம் புரட்சித்தலைவி அம்மா அவர்களின் ஆணைப்படி, ரூ.55.00 இலட்சம் நிதி ஒதுக்கீடு செய்யப்படும்.”

2. In accordance with the above announcement, the Additional Chief Secretary/Commissioner of Commercial Taxes in his letter read above has sent proposal for renovation of two lifts in Perarignar Anna Platinum Jubilee Memorial (PAPJM) Main Building, Greams Road, Chennai-6 and reported that the main building in that complex was constructed in the year 1983-1984. At that time, there were only two Territorial Divisions viz., Chennai (North) and Chennai (South) and one Enforcement Division and hence, only 18 offices were functioning in that building. Now, there are four Territorial Divisions and two Enforcement Divisions in Chennai and the number of offices functioning in that building raised to 70 and the number of staff and visiting public also increase manifold. All the four lifts erected at the time of construction became very old, of which two lifts become non-functional. In order to improve the public utility services, it is proposed to renew and modernize the two lifts in Perarignar Anna Platinum Jubilee Memorial (PAPJM) Building, Greams Road, Chennai-6, which have become non-functional. The Additional Chief Secretary/Commissioner of Commercial Taxes has therefore, requested the Government to sanction a sum of Rs.55,00,000/- (Rupees Fifty five lakh only) for

renovation of 2 Nos. 13 persons Passenger Lift at Perarignar Anna Platinum Jubilee Memorial (PAPJM) Main Building, Greams Road, Chennai-6.

3. The Government after careful examination of the proposal of the Additional Chief Secretary / Commissioner of Commercial Taxes in para 2 above, accord sanction for a sum of Rs.55,00,000/- (Rupees Fifty five lakh only) for renovation of 2 Nos. 13 persons Passenger Lift at Perarignar Anna Platinum Jubilee Memorial (PAPJM) Main Building, Greams Road, Chennai-6 as follows:-

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“4059 Capital Outlay on Public works – 01 Office Buildings –
051 Construction – Schemes in the Twelfth Five Year Plan -
II. State Plan – JN Commercial Taxes – 16 Major Works”
(DPC 4059 01 051 JN 1607).

5. The expenditure sanctioned in para 3 above constitutes an item of “New Instrument of Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from contingency fund and orders in this regard will be issued by Government in Finance (BG-I) Department separately. The Chief Engineer (Buildings), Public Works Department is directed to ascertain the actual amount required immediately till the next supplementary estimates and apply for sanction of the same as advance from the contingency fund to Finance (BG-I) Department in the prescribed format along with a copy of this order. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2016-2017 to Finance (BG-I)/Finance (PWD) Department at an appropriate time.

6. This order issues with the concurrence of Finance Department vide its U.O.No.4323/Finance(Revenue)/2017, dated 07.02.2017 and ASL No.2009 (Two thousand and nine).
