### **ORDER:-**

On the floor of the Assembly on 12.07.2017 the Hon'ble Minister (Commercial Taxes) has made the following Announcement among others under rule 110 of Tamil Nadu Legislative Assembly Rules :-

“வணிகவரித் துறையில், ஒவ்வொரு ஆண்டும், நிலம் பெறப்படுவதைப் பொறுத்து, போதுமான வசதியின்றி தனியார் வாடகைக் கட்டடங்களில் இயங்கி வரும் வணிகவரி அலுவலகங்களுக்கு படிப்படியாக அரசுக் கட்டடம் கட்டப்பட்டு வருகிறது. அந்த வகையில், 2017-2018 ஆம் ஆண்டில், விழுப்புரம் மாவட்டம், திருக்கோவிலூர் வணிகவரி அலுவலகத்திற்கு ரூ.103.951 இலட்சம் செலவில் சொந்தக் கட்டடம் கட்டப்படும்.”

2. In accordance with the above announcement, the Additional Chief Secretary/Commissioner of Commercial Taxes his letter read above has sent proposal for construction of Commercial Tax Office building (ground floor + 2 floors) at Thirukovilur in S.No.402/4 of Thirukovilur town, Villupuram District to accommodate the office of Commercial Tax Officer, Thirukovilur at a cost of Rs.99.23 lakhs for the year 2017-18 and requested the Government to accord administrative and financial sanction for the same.

3. The Government after careful examination of the proposal of the Additional Chief Secretary/Commissioner of Commercial Taxes, accord administrative and financial sanction for a sum of Rs.89,75,886/- (Rupees Eighty nine lakh seventy five thousand eight hundred and eighty six only) for the year 2017-2018 for the construction of Commercial Tax Office building (ground floor + 2 floors) at Thirukovilur in S.No.402/4 of Thirukovilur town, Villupuram District to accommodate the office of Commercial Tax Officer, Thirukovilur.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-

“4059- Capital Outlay on Public works – 01 Office Buildings – 051 Construction – State’s Expenditure – JN Commercial Taxes – 16 Major Works

(DPC 4059 01 051 JN 1607) ”.

5. The expenditure sanctioned in para 3 above constitutes an item of “New Instrument of Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund, regarding which will be issued by the Government in Finance (BG-I) Department, separately. The Chief Engineer (Buildings), Public Works Department is requested to send necessary proposals to the Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of an advance required for the current year from the Contingency Fund of the State. He is also requested to send a necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2017-2018 to Finance (BG-I) Department at an appropriate time.

6. This order issues with the concurrence of Finance Department vide its U.O.No.55197/Finance(Revenue)/2017, dated 03.11.2017 with Additional Sanction Ledger No.1795 (One thousand Seven hundred and ninety five)
