ORDER:-

On the floor of the Assembly on 31.08.2016 the former Chief Minister has made the following Announcement among others under rule 110 of Tamil Nadu Legislative Assembly Rules :-

“பணியாளர்கள் மற்றும் வணிகர்களுக்கு கூடுதல் வசதி செய்திடவும், பணி செய்வதற்கு உகந்த சூழ்நிலையை உருவாக்கிடவும், சொந்த கட்டடங்கள் தேவை என்பதைக் கருத்தில் கொண்டு, கடந்த ஐந்து ஆண்டுகளில் 64 அலுவலகங்களை உள்ளடக்கிய 33 கட்டடங்கள் கட்டப்பட்டுள்ளன. இந்த ஆண்டு கிருஷ்ணகிரி, நாமக்கல் மற்றும் பழனி ஆகிய 3 இடங்களிலும் 6 கோடியே 77 இலட்சம் ரூபாய் செலவில், 9 வணிகவரி அலுவலகங்களை உள்ளடக்கிய ஒருங்கிணைந்த வணிகவரிக் கட்டடங்கள் கட்டப்படும்.”

2. In accordance with the above announcement, the Additional Chief Secretary/Commissioner of Commercial Taxes in his letter read above has sent proposal for construction of Commercial Taxes Office building (ground floor + 2 floors) at Palani in S.No.123/4 of Palani village, Palani Taluk, Dindigul District to accommodate the offices of the Assistant Commissioner (Commercial Taxes), Palani-I,II and Commercial Tax Officer (Enforcement), Palani at a cost of Rs.162.80 lakhs for the year 2016-17 and requested the Government to accord administrative and financial sanction for the same.

3. The Government after careful examination of the proposal of the Additional Chief Secretary/Commissioner of Commercial Taxes in para 2 above, accord administrative sanction for a sum of Rs.1,53,15,386/- (Rupees One crore fifty three lakh fifteen thousand three hundred and eighty six only) for the construction of Commercial Taxes Office (ground floor + 2 floors) at Palani in S.No.123/4 of Palani village, Palani Taluk, Dindigul District to accommodate the office of Assistant Commissioner (Commercial Taxes), Palani-I, II and Commercial Tax Officer (Enforcement), Palani.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-

"4059 Capital Outlay on Public works - 01 Office Buildings -
051 Construction - Schemes in the Twelfth Five Year Plan -
II. State Plan - JN Commercial Taxes - 16 Major Works".
(DPC 4059 01 051 JN 1607).

5. The expenditure sanctioned in para 3 above constitutes an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department, separately. The Chief Engineer (Buildings), Public Works Department is requested to send necessary proposals to the Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of an advance required for the current year from the Contingency Fund of the State. He is also requested to send a necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2016-2017 to Finance (BG-I) Department at an appropriate time.

6. This order issues with the concurrence of Finance Department vide its U.O.No.3955/Finance(Revenue)/2017, dated 27.01.2017 with Additional Sanction Ledger No.1966 (One thousand nine hundred and sixty six).
