ORDER:

While moving the Demand for grants relating to Commercial Taxes for the year 2015-16 on the floor of the Legislative Assembly on 21.9.2015 the Hon'ble Minister (CT&R) has made the following announcement:-

#### (d) Functions of the Committee:

1.	To advise Government on CT Administration.	
2.	To advise Government on simplification of procedures and law.	
3.	To take efforts to bring in monitoring better compliance of VAT and other laws by businesses.	
4.	To improve working procedures to enable ease of doing business.	
5.	To design ways to reduce tax evasion.	
6.	To identify measures to minimize tax disputes.	
7.	To find ways and means to improve tax collections.	
8.	To suggest ways to act against defaulters.	
9.	To recommend measures for GST preparedness.	
10.	To promote and provide uniform application of VAT and other CT laws.	

#### (e) Procedure to be followed by the Committee:

1.	The Committee will meet not less than twice a year on dates notified by the Chairman of the Committee.
2.	The Date and Venue of the Committee meeting will be intimated through E-mail or phone number of the Committee members available in the records, 7 days before each meeting.
3.	No Traveling and other Allowances will be given to the members participating in the Committee meeting.
4.	Duration of the Committee is three years from the date of issue of G.O. or restructuring of the Committee members whichever is later.
5.	The member representing the Chamber of Commerce and other Associations shall bring all authorization.
6.	The Chairman will report the findings of the Committee to Government from time to time.
