NOTIFICATION.

In exercise of the powers conferred by section 12 of the Tamil Nadu Tax on Entry of Motor Vehicles into Local Areas Act, 1990 (Tamil Nadu Act 13 of 1990), the Governor of Tamil Nadu, having considered it necessary to do so in the public interest, hereby exempts any importer from payment of the whole of the tax payable under said Act in respect of entry of cars and two wheelers into any local area for sale thereon to Tvl. Taipei Economic and Cultural Centre in Chennai and its home-based officials in Tamil Nadu for their official and personal use under reciprocal arrangements with India.

2. This Notification shall come into force with effect on and from 28 February 2014
