APPENDIX
NOTIFICATION

In exercise of the powers conferred by sub-sections (1) and (2) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes an exemption in respect of the tax payable under the said Act by any dealer on the sale of raw materials used in the manufacture of artificial limbs and calipers to Tvl.Mukti (M.S. Dadha Foundation), Chennai, subject to the following conditions that.-

- (i) the seller shall furnish a declaration duly filled in and signed by the said Foundation in the format annexed herewith along with the monthly return to the assessing officer; and
- (ii) the goods shall be used by the said Foundation for the purpose of manufacture of artificial limbs and calipers and supplied to the beneficiaries at free of cost.

2. The exemption hereby made shall remain in force for two years from the date of publication of this Notification.
