NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes an exemption in respect of the tax payable under the said Act on the sale of copra procured under Price Support Scheme by the Tamil Nadu Co-operative Marketing Federation Limited (TANFED) and Primary Co-operative Societies for National Agricultural Co-operative Marketing Federation Limited (NAFED).

2. The exemption hereby made shall come into force on the $15^{\rm th}$ June 2016 and shall remain in force upto and inclusive of the $14^{\rm th}$ December 2016.
