ORDER:

In the Government Order first read above, the Government have ordered fixing the estimate of vacancies in the cadre of Joint Commissioner (Commercial Taxes) in the Commercial Taxes Department for the year 2014 as '12' (twelve).

- 2. In the letter second read above, the Principal Secretary/Commissioner of Commercial Taxes has stated that up to 31.10.2014 there were 7 vacancies in the cadre of Joint Commissioner (Commercial Taxes) and in the meanwhile in G.O Ms. No.23, Commercial Taxes & Registration (A2) Department, dated 26.2.2014, orders have been issued for the reorganization of Chennai Commercial Taxes Divisions and among others, one post of Joint Commissioner (Commercial Taxes) has been created in the Business Intelligence Unit in the Office of the Principal Secretary / Commissioner of Commercial Taxes, by upgrading one post of Deputy Commissioner (Commercial Taxes) in the appellate wing of the department. Therefore, taking into account of this post also, the total vacancies in the cadre of Joint Commissioner (Commercial Taxes) come to 8 (eight).
- 3. The Principal Secretary/Commissioner of Commercial Taxes has emphasized that in order to achieve the revenue target fixed by the Government and in the interest of the Government revenue, filling up of the eight vacant posts of Joint Commissioner (Commercial Taxes) in the Commercial Taxes Department is necessary and sent his recommendations to the Government to consider the drawal

of temporary list in the cadre of Joint Commissioner (Commercial Taxes) to fill up these vacancies.

- 4. As per the orders issued in G.O. (Ms.) No.368, Personnel and Administrative Reforms (Per.S) Department, dated 18.10.1993, where a panel is prepared after the relevant panel year, only the actual number of vacancies which really arose should be reckoned. The crucial date for the drawal of the temporary list of Joint Commissioners (Commercial Taxes) for the year 2014 is 1.1.2014 and the estimation period is from 2.1.2014 to 1.1.2015. As such, the panel year for the drawal of temporary list for the year 2014 has got completed.
- 5. Accordingly, the Government after careful consideration, hereby restricts the drawal of temporary list of Joint Commissioners (Commercial Taxes) for the year 2014 to the actual vacancies that exists in the said category, i.e. 8 (eight) during the panel period and order accordingly. The temporary list drawn is purely on adhoc basis and will not confer any right on the individuals to claim seniority in future.
- 7.
