Sub: Method of remittance of fee under section 7(1) of Right to Information Act, 2005 - To be informed to the petitioners - Instructions - Issued.


Ref: Letter No.39998/AR.III/2007-5, Personnel and Administrative Reforms (AR.III) Department, dated 18.12.2007.

I am directed to invite your attention to the letter cited wherein instructions have been issued that charges for providing information / documents under the Right to Information Act, 2005 may be received by way of Treasury Challan or by Bankers cheque or by Demand Draft or Cash. This has to be intimated to the petitioners while the Public Information Officer is communicating the charges to be paid by the petitioner for providing information under section 7 (1) of the Right to Information Act, 2005. But, complaints are being received by this department that the Public Information Officers are not properly intimating the mode of payment while replying to the petitioner under section 7(1) of the Right to Information Act, 2005. Therefore all the Public Information Officer under your control may please be instructed to inform the petitioners the modes of payment, while replying to the petitioner under section 7(1) of the Right to Information Act, 2005, as given below:-
