## ORDER:

In the reference 1<sup>st</sup> cited, System Analyst-I, was originally appointed as Public Information Officer under the Right to Information Act, 2005, in the Office of the Joint Commissioner (Computer Systems).

- 2. Following re-organization of the Commercial Taxes Department, certain Joint Commissioners concerned have suggested to appoint a fresh Public Information Officers and First Appellate Authorities in respect of certain wings and requested to remove certain Public Information Officers and First Appellate Authorities from the list already published. Accordingly, in suppression of earlier appointments, new set of Public Information Officers / First Appellate Authorities in respect of the Commercial Taxes Department are reappointed as in the reference 2<sup>nd</sup> cited.
- 3. As per the reference 1<sup>st</sup> cited, System Analyst-I post was held by Thiru S. Ramasamy. Subsequently, the Official was promoted and posted as Joint Commissioner (Computer Systems) on 16.11.2017 vide G.O. (D) No. 414, CT & R Department, dated 16.11.2017. Hence, an interim arrangement was made to appoint Deputy Programmer as Public Information Officer, as all the post of System Analyst were vacant.
- 4. On completion of the deputation period on Foreign Service on 04.10.2018, Thiru J. Rasaldoss Solomon joined in the Office of the Joint Commissioner (Computer Systems) as System Analyst-II and therefore, he was subsequently ordered to be placed as Full Additional

Charge to the post of System Analyst-I vide Proceedings of the Commissioner of Commercial Taxes in CP3/395/2018, dated 23.10.2018.

- In G.O. 2<sup>nd</sup> cited, the Government have decided to upgrade one post of System Analyst in Commercial Taxes Department to that of Joint Commissioner and designate the upgraded post as Joint Commissioner (Information Technology)and appointed Thiru J. Rasal Doss Solomon, System Analyst-II in the upgraded post of Joint Commissioner (Information Technology).
- 5. In view of the above, all the posts including the post of System Analyst-III became vacant and the official Thiru M S Ifthikar Ahamed who held that post is still on deputation on Joint Director (Technical) in the Commissionerate of e-Governance.
- 6. As the present incumbents in the post of System Analyst I and III are vacant, Thiru R. Sivaramakrishnan, Deputy Programmer is nominated as Public Information Officer under the Right to Information Act, 2005, in the Office of the Joint Commissioner (Computer Systems).
- 7. The above arrangement will come into effect immediately and holds goods till the incumbents join in the post of System Analysts.
