**ORDER:**

In exercise of the powers conferred by sub-section (1) of Section 96 of the Tamil Nadu Goods and Services Tax Act, 2017, a notification was issued for the appointment of members to the Tamil Nadu Authority for Advance Ruling. However, no official post was created to the newly constituted Tamil Nadu Authority for Advance Ruling except appointment of two official members. Hence, Public Information Officer and First Appellate Authority who were already appointed for the office of the Joint Commissioner (CT) (Enforcement), Inter-State Investigation Cell, Chennai are hereby appointed as Public Information Officer and First Appellate Authority respectively under the Right to Information Act, 2005, with full additional charge in respect of the office of the Tamil Nadu Authority for Advance Ruling until regular postings allotment are made. The appointed officers are requested to act as per the provisions of the Right to Information Act, 2005.

2. As the office of the Joint Commissioner (CT) (MoU) Cell was merged with the newly created Service Tax Cell, the Public Information Officer and First Appellate Authority already appointed under the Right to Information Act, 2005 to the office of the Joint Commissioner (CT) MoU Cell in the reference 4<sup>th</sup> cited, is hereby cancelled.
