ORDER:

Following the re-organisation of the Commercial Taxes Department in the light of the implementation of the Goods and Services Tax Act, 2017 and other changes, orders were issued by the Government in G.O. Ms. No. 30, Commercial Taxes and Registration (A2) Department, dated 04.03.2019, and on that basis,

proceedings were issued by the Commissioner of Commercial Taxes, for the changes in nomenclature of certain posts in Commercial Taxes Department and consequently, Public Information Officers / First Appellate Authorities in respect of the Commercial Taxes Department are re-appointed in the reference 1st cited.

- 2. In the reference 2nd cited, the Personnel and Administrative Department has informed that action is being taken to develop/modify software applications to enable online filing of RTI petitions and first appeals. For this purpose they have requested to update the details of designated Public Information Officers and First Appellate Authorities functioning under the administrative control including District level and field level in a spread sheet format and to send the copy of the same within a month's time (on or before 28.02.2020).
- 4. In the reference 3rd cited the Government have requested to expedite the process of updating the details of designated Public Information Officers and First Appellate Authorities functioning under the Commercial Taxes Department.
- 5. Hence, proposals called for from the officers concerned for re-appointment of Public Information Officers and First Appellate Authority under the Right to Information Act, 2005.
- 6. Accordingly, in the references 5th to 31st cited, proposal has been received from the Joint Commissioners Territorial, Intelligence Wing, Large Tax Payers' Unit, Computer Systems, Authority for Advance Ruling under GST Act, 2017 (including Appellate Forum), Commercial Tax Staff Training Institute, Traders Welfare Board, Joint Commissioner, GST Appeals and State Representative, Additional State Representative, STAT, Chennai, Additional State Representative, STAT (AB), Madurai and Coimbatore for updating the details of designated Public Information Officers and First Appellate Authorities.
- 7. Further, as requested by this office, certain Joint Commissioners concerned have suggested to appoint a fresh Public Information Officers and First Appellate Authorities in respect of certain wings and requested to remove certain Public Information Officers and First Appellate Authorities from the list already published vide reference 1st cited.
- 7.1 Further, in respect of Deputy Commissioner (GST-Appeal), Chennai-I Office, <u>Deputy Commissioner (GST-Appeal)</u>, <u>Chennai-I and Joint Commissioner (ST) Chennai North Division are appointed as Public Information Officer and First Appellate Authority respectively on par with appointment of Public Information Officer and First Appellate Authority for the Office of the Deputy Commissioner (GST-Appeal), Chennai-II as per the</u>

request made by the Joint Commissioner (ST), Chennai (East) Division in the reference 14th cited.

- 8. Accordingly, in suppression of appointment of Public Information Officer and First Appellate Authority made in the reference 1st cited, Public Information Officers / First Appellate Authorities in respect of the Commercial Taxes Department are reappointed as in the Annexure.
- 9. Further, the Public Information Officers and First Appellate Authorities concerned are directed to inform any subsequent change of official address, telephone numbers and e-mail id, directly to the Joint Commissioner (Computer System) under intimation to this office in order to make changes to facilitate the applicants file Right to Information application through online system. As and when any such intimation/request are received from the Public Information Officers and/or First Appellate Authorities concerned, the Joint Commissioner (Computer System) is permitted to make necessary changes to incorporate in the annexure and upload in the Departmental website.
- 10. The appointed officers are requested to act as per the provisions of the Right to Information Act, 2005.
