Besides, all the Public Information Officers / First Appellate Authorities nominated by the Commercial Taxes Department are instructed to dispose the application received under the Right to Information Act, 2005, with in the time limit prescribed and as per the provisions under the said Act.

All Officers are requested to pay personal attention in this matter and take concrete steps to ensure strict compliance to the provisions of the RTI Act. No further time will be given in this regard.

The non-furnishing of replies to the pending references and non-furnishing of report within the stipulated date, i.e., 30.09.2023, will be viewed seriously.


