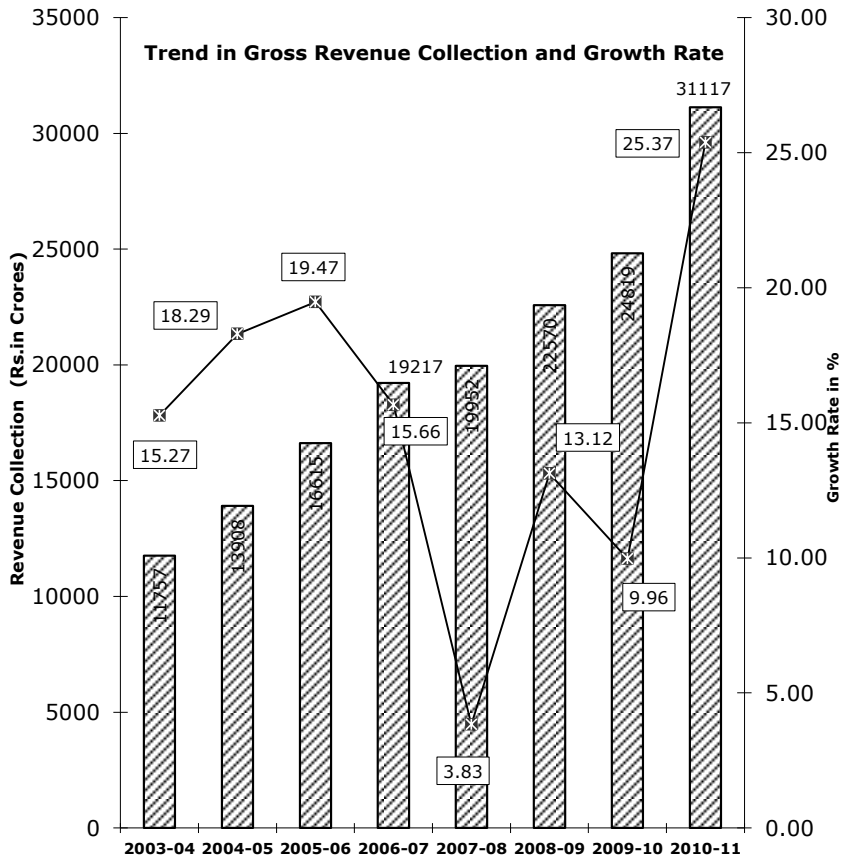

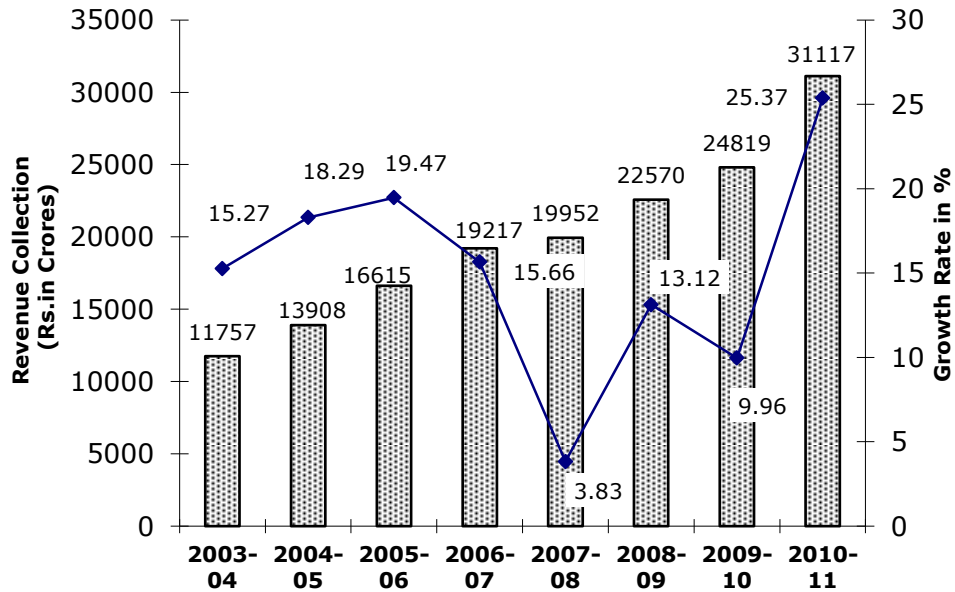

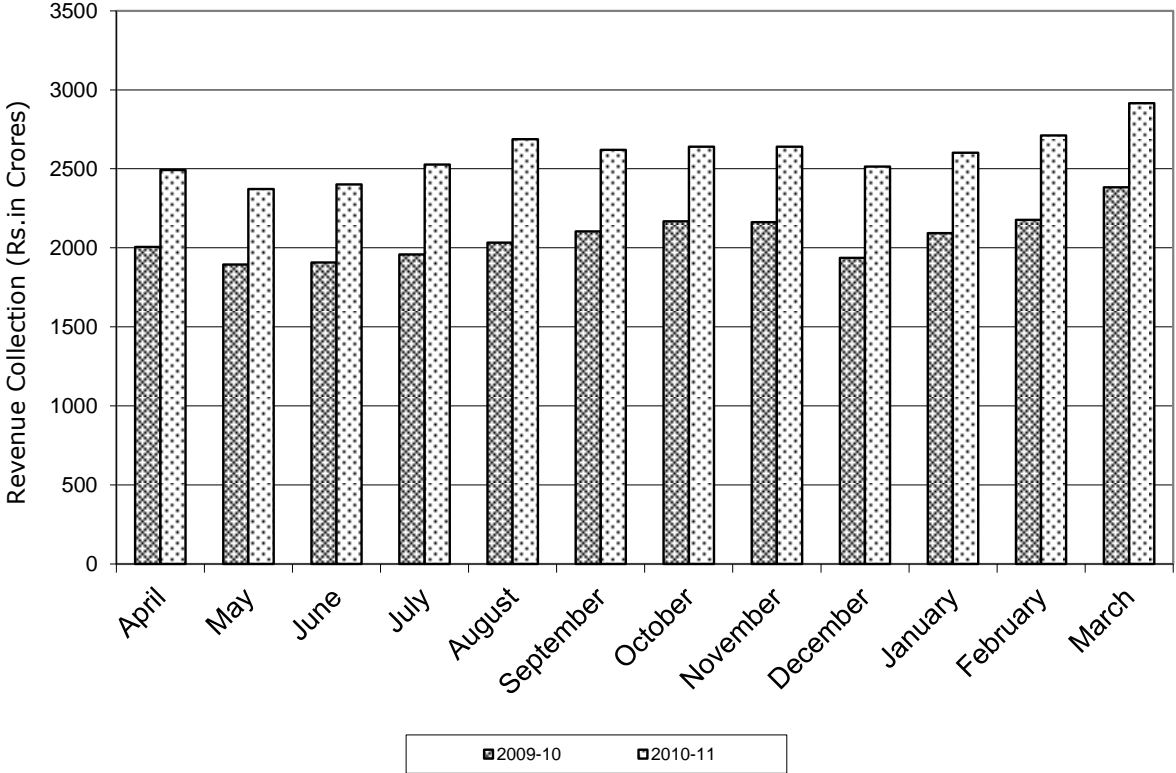
Trend in Gross Revenue Collection and Growth Rate

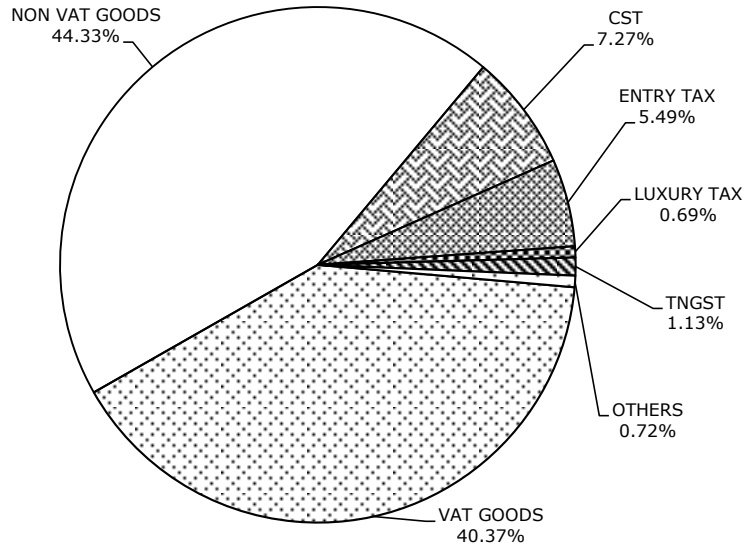

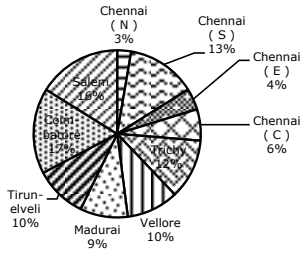

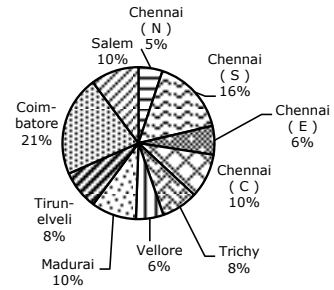

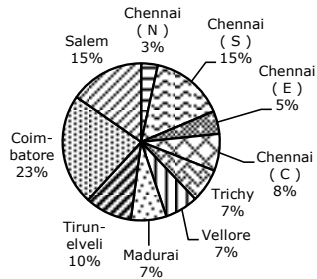
Division-wise Share of VAT Registered Dealers



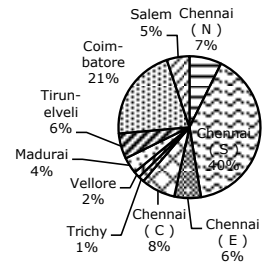
Division-wise Share of VAT Dealers filing Monthly Returns

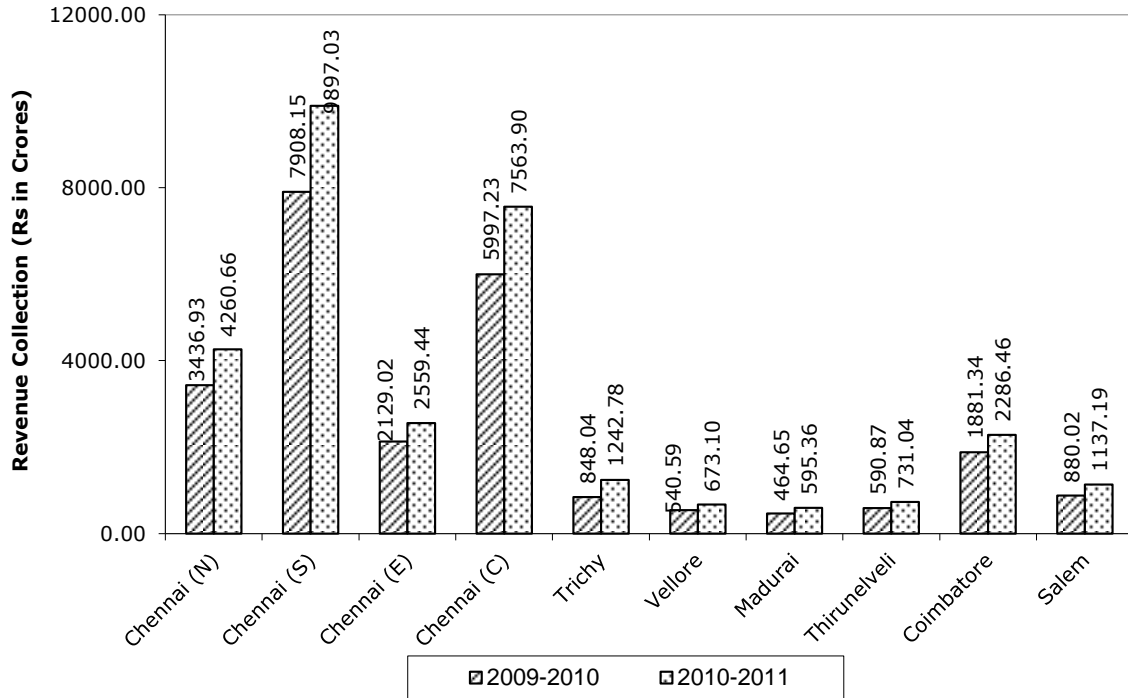

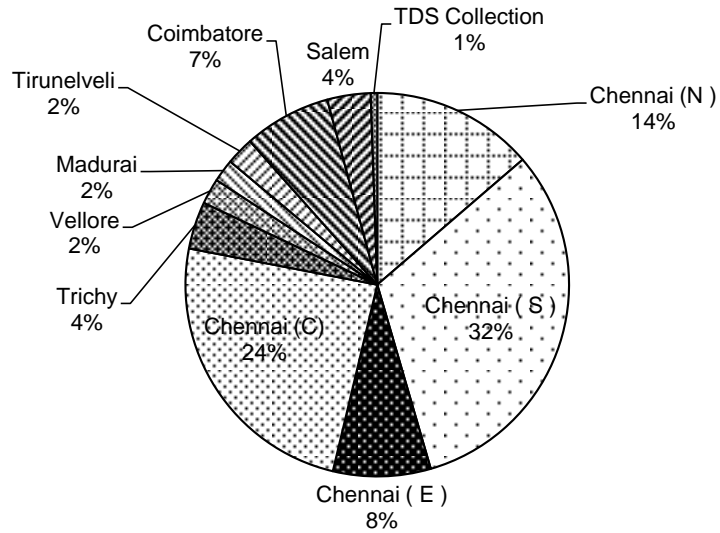
