

**NOTIFICATION-I.**

In exercise of the powers conferred by sub-section (3) of section 1 of the Tamil Nadu Sales Tax (Settlement of Arrears) Act, 2010 (Tamil Nadu Act 20 of 2010), the Governor of Tamil Nadu hereby appoints the 1st day of June 2010, as the date on which the said Act shall come into force.

**NOTIFICATION -II.**

In exercise of the powers conferred by section 3 of the Tamil Nadu Sales Tax (Settlement of Arrears) Act, 2010 (Tamil Nadu Act 20 of 2010), the Governor of Tamil Nadu hereby appoints the Joint Commissioner of Commercial Taxes to be the designated authority in respect of any dealer within his jurisdiction, with effect on and from the 1st day of June 2010.

**NOTIFICATION-III.**

Under sub-section (3) of section 8 of the Tamil Nadu Sales Tax (Settlement of Arrears) Act, 2010 (Tamil Nadu Act 20 of 2010), the Governor of Tamil Nadu hereby notifies the Commissioner of Commercial Taxes to be the authority for the purpose of the said sub-section (3), with effect on and from the 1st day of June 2010.
