Certain representations have been received requesting for clarification regarding applicability of GST on supply of service by State Government to their undertakings or PSUs by way of guaranteeing loans. The issue was examined by GST Council in its 43<sup>rd</sup> meeting held on 28<sup>th</sup> May, 2021.

- 2. Entry No. 34A of G.O. (Ms) No. 73 dated 29.06.2017 published in Tamil Nadu Government Gazette Extraordinary in Issue No.202 in Notification No.II (2)/CTR/532(d-15)/2017, dated 29.6.2017 exempts "Services supplied by Central Government, State Government, Union territory to their undertakings or Public Sector Undertakings (PSUs) by way of guaranteeing the loans taken by such undertakings or PSUs from the banking companies and financial institutions."
- 3. Accordingly, as recommended by the Council, it is re-iterated that guaranteeing of loans by Central or State Government for their undertaking or PSU is specifically exempt under said entry No. 34A.
