In exercise of the powers conferred under the proviso to sub-section (1) of section 10 of the Tamil Nadu Goods and Services Tax Act, 2017 (Tamil Nadu Act 19 of 2017), the Governor of Tamil Nadu, on the recommendations of the Council, hereby makes the following further amendments in the Commercial Taxes and Registration Department Notification No.II(2)/CTR/212(g-4)/2019, published at pages 4-5 in Part II-Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated 7<sup>th</sup> March, 2019, namely:-
