ABSTRACT

Tamil Nadu Government Servants' Application for Posts Rules, 1973 – Applicability of procedure to Tamil Nadu Public Service Commission and other recruiting authorities – Amendment to Rule 3 – Orders – Issued.

ORDER :

The Tamil Nadu Government Servants' Application for Posts Rules, 1973 prescribes the procedure to be followed by Government Servants while applying for a service under the administrative control of the State Government or to any post therein.

2) The proviso to rule 3(1) of the said Rules provides for the procedure to be followed by the Government Servants while applying for a post directly or through online, to the Tamil Nadu Public Service Commission (TNPSC) above.

3) In practice, Government servants apply for posts not only to Tamil Nadu Public Service Commission, but also apply for posts recruited by the other recruiting agencies or authorities of other State Governments and Government of India.

4) Accordingly, the Government have decided to amend rule 3 of the Tamil Nadu Government Servants' Application for Posts Rules, 1973.

5) The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Servants' Application for Posts Rules, 1973:-

AMENDMENTS.

In the said Rules, in rule 3,-

(1) in sub-rule (1),-

(a) for the expression "in another office or department of the State Government or under another State Government or the Government of India", the following expression shall be substituted, namely:-

"in another office or department of the State Government or under another State Government or the Government of India or Public Sector Undertakings or Universities or Co-operative Societies or Local Bodies or any other Quasi-Government organisations,";

(b) in the proviso to sub-rule (1), after the expression, "Tamil Nadu Public Service Commission," occurring in two places the following expression shall be inserted, namely:-

"or other Recruiting Agencies or the Authorities of other State Governments or the Government of India or Public Sector Undertakings or Universities or Co-operative Societies or Local Bodies or any other Quasi-Government organisations,".

(2) in sub-rule (2), after the expression, "Tamil Nadu Public Service Commission", occurring in two places the following expression shall be inserted, namely:-

"or other Recruiting Agencies or the Authorities of other State Governments or the Government of India or Public Sector Undertakings or Universities or Co-operative Societies or Local Bodies or any other Quasi-Government organisations".

(3) in sub-rule (3), in the Annexure, for the existing Form, the following Form shall be substituted, namely:-
