ORDER:

The Additional Chief Secretary/Commissioner of Commercial Taxes in the letter first read above has stated that the panel of Deputy Commissioners (CT) for the past few years could not be drawn due to the inter-se-seniority issue pending before the Hon'ble High Court of Madras as well as due to the decision taken to revisit the seniority from the year 2007 onwards from the cadre of Assistant Commissioner (CT). As it would have a consequential effect in the higher cadre, the Additional Chief Secretary/ Commissioner of Commercial Taxes has stated that it was decided to await the revised list to be published by the Government. However, aggrieved against the drastic consequences on account of revisit of seniority, certain officials, namely, Tvl. D.Soundararajapandian

and 2 others have filed Writ Petitions before the Hon'ble High Court of Madras in W.P. Nos.9257/2018, 9258/2018 and 9326/2018 and the Hon'ble High Court has ordered that status quo shall be maintained in the matter. The Hon'ble High Court has also reserved the final orders in this case. Further, the Additional Chief Secretary/Commissioner of Commercial Taxes has informed that repeated requests have been made by both direct recruits as well as transferees for temporary promotion to the post of Deputy Commissioners (CT), subject to the final orders to be passed in the above Writ Petitions.

2. The Additional Chief Secretary/Commissioner of Commercial Taxes has examined the said representations for adhoc promotion and stated that those officials who were included in the permanent lists of Assistant Commissioner (CT) upto the year 2010 were promoted as Deputy Commissioners (CT); and for the years 2011 and 2012, the permanent list was declared as 'Nil'. For the year 2013, the Government have drawn a permanent list of Assistant Commissioners (CT) in G.O (Ms) No.98, Commercial Taxes and Registration (E1) Department, dated 22.12.2014 in which the following officials figure in:-

3. The Additional Chief Secretary/Commissioner of Commercial Taxes has stated that as on date there are 43 vacancies in the cadre of Deputy Commissioner (CT) and accordingly recommended that the following eight eligible Assistant Commissioners (CT) who were included in the regular panels of Assistant Commissioners (CT) be promoted to the post of Deputy Commissioners (CT) on adhoc basis, in tune with the principles of the High Court of Madras / Supreme Court of India:-

- 5. Taking into account the existing vacancies in the cadre of Deputy Commissioner (CT), the Additional Chief Secretary/Commissioner of Commercial Taxes has sent proposals to Government for adhoc promotion to the post of Deputy Commissioner (CT) in the letters first and third read above; and in the letter fifth read above, necessary proposals for postings have also been sent to Government.
- 6. The Government have examined the proposal of the Additional Chief Secretary/Commissioner of Commercial Taxes in greater detail. Taking into account the aspects of revenue collection and other statutory functions vested in the post of Deputy Commissioner (CT) under the Acts administered by the department including the recently implemented Tamil Nadu Goods and Services Act, 2017, the Government have decided the following:-
- (i) Taking into account of the adjudication on inter-se-seniority pending before the High Court of Madras, to fill up the eight existing vacancies in the cadre of Deputy Commissioner (CT) on provisional basis, for administrative reasons, with eligible Assistant Commissioners (CT) who fit into the zone of consideration;
- (ii) To provisionally promote the following eight Assistant Commissioners (CT) as Deputy Commissioners (CT) as per their seniority and eligibility for promotion, subject to the outcome of the final orders to be passed by the Hon'ble High Court of Madras in W.P Nos.9257/2018, 9258/2018 and 9326/2018 filed by Thiru D.Soundararajapandian and 2 others:-

(iii) The said provisional promotion will not bestow any seniority rights vis-à-vis their promotion to the next higher cadre and will also be subject to the condition that adverse remarks, if any, for the period from 1.4.2013 to 31.3.2018 in the confidential reports, which are yet to be written for the said period, would be held against the said officials.

7. Accordingly, the Government direct that the following Assistant Commissioners (Commercial Taxes) be promoted as Deputy Commissioners (Commercial Taxes) on a provisional basis with immediate effect, subject to the conditions mentioned in paragraph 6 above, in the order of their seniority in their present post:-
