In exercise of the powers conferred by Rule 48 of the General Rules under Part-II of Tamil Nadu State and Subordinate Services, contained in Volume-I of the Tamil Nadu Services Manual, the Governor of Tamil Nadu hereby relaxes the provisions in Explanation-III under Rule 4(a) of the General Rules for Tamil Nadu State and Subordinate Services in favour of the FORTY officials mentioned in para 4 above and to relax the Special Rule 4(c) and 5(a) of Tamil Nadu Commercial Taxes Services relating to completion of probation and completion of one year of assessment work respectively in respect of the following SEVEN candidates only, since they were appointed as Assistant Commissioners (Commercial Taxes) during September 2012 vide G.O. (Ms.) No.116, Commercial Taxes and Registration (E1) Department, dated 24.8.2012 viz., Tvl.C.Arumugam (Sl.No.2), Bowsiya Banu.A (Sl.No.4), Dhanupriya.R (Sl.No.5), Murugesan.S (Sl.No.7), Sudhagar.C (Sl.No.8), Krishnasamy.R (Sl.No.9) and Sathya.J (Sl.No.11) so as to enable them for inclusion in the temporary list of Assistant Commissioners (Commercial Taxes) fit for promotion as Deputy Commissioners (Commercial Taxes) for the year 2013. The temporary list is purely on adhoc basis and will not confer any right on the individuals to claim seniority in future.

6. The Commissioner of Commercial Taxes is requested to communicate the approved temporary list indicated in para 4 above to the individuals concerned as per the procedure laid down in G.O. 
