## **ORDER:**

The Commercial Taxes Department has recently embarked on a massive revenue augmentation exercise through substantive reorganization, redeployment, upgradation and creation of posts as well as implementation of Samadhan Scheme 2023 for collection of old arrears. But, the existence of huge number of vacancies in all categories in the State and Subordinate Services is hampering the revenue collection efforts of the Department. In the category of Assistant Commissioner (CT), out of the 383 posts in existence as on date, nearly 41%, i.e., about 157 posts are vacant as on date. Therefore, the Commissioner of Commercial Taxes has sent proposals to Government for drawal of a temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners(CT) by recruitment by transfer in the State Service on the basis of the provisional inter-se seniority lists in the categories of Deputy Commercial Tax Officer and Commercial Tax Officer respectively (provisionally published by the Commissioner of Commercial Taxes on 27.12.2023) to fill up the actual vacancies in the post of Assistant Commissioners(CT).

2. Pending finalization of inter-se seniority between direct recruits and transferees in Subordinate Service and consequentially in State Service, the Commissioner of Commercial Taxes, in the letter read above, has proposed the names of 100 individuals for appointment to the post of Assistant Commissioner(CT) which include the names of 37 persons who are still Commercial Tax Officers but whose names find place in the Assistant Commissioner category in the lists for the years 2016 and 2018 now

prepared in the ongoing revision exercise as well as the names of 63 persons who are Commercial Tax Officers and are coming up for consideration for appointment as Assistant Commissioner (CT) in the year 2023 on account of upward revision of their seniority in the Commercial Tax Officer category due to drawal of the inter-se seniority lists and adoption of rule of reservation for BC and MBC in the said revision exercise.

- 3. The Government have examined the proposal of the Commissioner of Commercial Taxes in greater detail and have decided as follows:-
- (i) Pending finalization of inter-se seniority between direct recruits and transferees in Subordinate Service and consequentially in State Service, and also considering the large number of vacancies in the cadre of Assistant Commissioners(CT) which is hampering revenue collection of the Department, to accept the proposal of the Commissioner of Commercial Taxes to fill up the 100 vacancies for the year 2023 by drawal of temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners(CT) by recruitment by transfer for the year 2023 on the basis of the seniority provisionally determined in the ongoing list revision exercise;
- (ii) To temporarily appoint the following 76 (seventy-six) fully fit Commercial Tax Officers as Assistant Commissioner(CT) as per their seniority and eligibility for appointment, subject to the confirmation of the seniority/inter se seniority in the feeder categories and the outcome of W.A.No.1100 of 2023 filed by Thiru. C.Sundaramurthy, Assistant Commissioner(CT):-
