ORDER:

In the Government Order second read above, temporary list of nine Deputy Commissioners (Commercial Taxes) fit for promotion as Joint Commissioners (Commercial Taxes) for the year 2013 has been drawn.

2. The Special Rule 4(d) of the Tamil Nadu Commercial Taxes Service prescribes that, for appointment as Deputy Commissioner (now re-designated as Joint Commissioner of Commercial Taxes), one must not have completed 57 years of age on the first day of July of the year for which the list is drawn. As Thiru.P.Elango, Deputy Commissioner (Commercial Taxes) has completed 57 years as on 1.7.2013, his name was not considered in the temporary list of Deputy Commissioners fit for promotion as Joint Commissioners drawn in the Government Order second read above.

3. It has been brought to the notice of the Government that, the rule relating to age was already relaxed for appointment of Deputy Commercial Tax Officers as Commercial Tax Officers (now Assistant Commissioners) for the year 2009-10 in the Government Order first read above. It has therefore been decided by the Government to consider the name of Thiru.P.Elango, Deputy Commissioner (Commercial Taxes) for inclusion in the temporary list of

Deputy Commissioners (Commercial Taxes) fit for promotion as Joint Commissioners for the year 2013 by relaxing Rule 4 (d) of the Tamil Nadu Commercial Taxes Services relating to age. Accordingly, the Commissioner of Commercial Taxes has sent necessary proposal to Government in the reference third cited, so as to include the name of Thiru.P.Elango, Deputy Commissioner (Commercial Taxes) in the temporary list of Deputy Commissioners fit for promotion as Joint Commissioners for the year 2013 as a special case.

4. In exercise of the powers conferred by Rule 48 of the General Rules under Part-II of Tamil Nadu State and Subordinate Services, contained in volume-I of the Tamil Nadu Services Manual, the Governor of Tamil Nadu hereby relaxes the provisions in Explanation-III under Rule 4(a) of the General Rules for Tamil Nadu State and Subordinate Services and Rule 4(d) of Tamil Nadu Commercial Taxes Services relating to age in favour of Thiru.P.Elango, so as to include his name in the temporary list of Deputy Commissioners (Commercial Taxes) fit for promotion as Joint Commissioners (Commercial Taxes) for the year 2013. Accordingly the name of Thiru.P.Elango, Deputy Commissioner (Commercial Taxes) is included in the temporary list drawn in the Government Order second read above in relaxation of the rules mentioned above and his name is placed at Sl.No.3A below Thiru.P.Kasiviswanathan (Sl.No.3) and above Thiru.R.Gnanaprakasan (Sl.No.4).

5. The Commissioner of Commercial Taxes (i/c) is requested to communicate the inclusion of the name of the individual indicated in para 4 above as per the procedure laid down in G.O (Ms.) No.707, Personnel and Administrative Reforms (Per.M) Department, dated 3.7.1981 and obtain proper acknowledgement from him.


