In the Government order first read above, orders were issued for the drawal of a temporary list of Assistant Commissioners (Commercial Taxes) in the Commercial Taxes Department for the year 2015-2016.

- read above, the Principal 2. In the letter second Secretary/Commissioner of Commercial Taxes has stated that at the time of drawal of temporary list of Assistant Commissioners (Commercial Taxes) for the year 2014-2015, Thiru T.Gurusamy Pandian, Commercial Tax Officer did not pass the Accounts Test for Executive Officers, which is a statutory qualification for inclusion in the list of Assistant Commissioners (Commercial Taxes). Hence, his name was not included in the said panel. Due to the nonavailability of the details of individual who had passed the Accounts Test for Executive Officer at the time of drawal of temporary list of Assistant Commissioners for the year 2015-2016, the name of Thiru T.Gurusamy Pandian, Commercial Tax Officer was omitted to be included in the said list for the year 2015-2016. The Principal Secretary/Commissioner of Commercial Taxes has stated that it was subsequently brought to the notice that the above official had passed the Accounts Test for Executive Officers in May 2014, which was published in TNPSC Bulletin No.18, dated 16.08.2014.
- According to the Special Rules for Tamil Nadu Commercial Taxes Services, a person should have passed in the Accounts Test for Executive

Officers for appointment to post of Assistant Commissioner (Commercial Taxes) through recruitment by transfer from the Tamil Nadu Commercial Taxes Subordinate service and the said qualification should be acquired before the 1<sup>st</sup> day of January of the year in which the report to the Commission about the fitness of the candidates for inclusion in the list becomes due. As Thiru T.Gurusamy Pandian, Commercial Tax Officer has passed the Accounts Test for Executive Officers in May 2014 itself, the Principal Secretary / Commissioner of Commercial Taxes has sent proposals to include his name (rank No.156 of 2010 in the post of Commercial Tax Officer) in the temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners (Commercial Taxes) for the year 2015-2016 in the first place i.e. above the name of Tmt B.Vanithamani (rank No.9/2011 in the post of Commercial Tax Officer).

- 4. The Government, after careful consideration, direct that the name of Thiru T.Gurusamy Pandian, Commercial Tax Officer (Enforcement), Thanjavur be included in the temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners (Commercial Taxes) for the year 2015-2016 and be assigned Rank No.1 by placing him first i.e. above the name of Tmt B.Vanithamani, Assistant Commissioner (Commercial Taxes) whose rank is reassigned as No.1-A.
- 5. This order is purely drawn on ad-hoc basis and it does not confer any right on the individual to claim seniority in future and it is subject to the outcome of the cases indicated in the Government Order first read above.
