ORDER:

In the Government order first read above, orders were issued for the drawal of a temporary list of Assistant Commissioners (Commercial Taxes) in the Commercial Taxes Department for the year 2014-2015.

In the representation third read above, Tmt.C.Uthayarani, Commercial Tax Officer, Madurai has requested to include her name in the temporary list of Assistant Commissioners (Commercial Taxes) for the year 2014-2015, as the disciplinary proceedings initiated against her under rule 17(b) of the Tamil Nadu Civil Services (Discipline & Appeal) Rules were dropped by the Principal Secretary/Commissioner of Commercial Taxes in proceedings No.CD1/11353/2014, dated 02.03.2016.

3. In the letter fourth read above, the Principal Secretary/Commissioner of Commercial Taxes has stated that disciplinary proceedings were initiated against Tmt.C.Uthayarani, Commercial Tax Officer, Madurai under rule 17(b) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules for certain lapses committed by her while she was working as Assistant Commissioner (Commercial Taxes) (Full Additional Charge), Bodinayakkanur assessment circle. Her name was deferred for inclusion in the temporary list of Assistant Commissioners (Commercial Taxes) for the year 2014-2015 due to the pendency of the disciplinary action against her.

Subsequently, the above disciplinary proceedings were ordered to be dropped. Therefore, the Principal Secretary/Commissioner of Commercial Taxes has recommended to include the name of Tmt.C.Uthayarani, Commercial Tax Officer (Audit), Office of the Deputy Commissioner (Commercial Taxes), Madurai in the temporary list of Assistant Commissioners for the year 2014-2015 drawn in the Government Order first read above by including her name in between Thiru.K.Nagarajan, Assistant Commissioner (Commercial Taxes) (Sl.No.16)(senior) and Thiru.R.Senrayan, Assistant Commissioner (Commercial Taxes) (Sl.No.16-A) (junior). The Principal Secretary/Commissioner of Commercial Taxes has also stated that Tmt.C.Uthayarani, Commercial Tax Officer, Madurai has acquired the requisite qualifications as prescribed in the special rules for Tamil Nadu Commercial Taxes service.

4. The Government, after careful consideration, direct that the name of Tmt.C.Uthayarani, Commercial Tax Officer, Madurai be included in the temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners (Commercial Taxes) for the year 2014-2015 drawn in the Government Order first read above and place her in between Thiru.K.Nagarajan, Assistant Commissioner (Commercial Taxes) (Sl.No.16) (senior) and Thiru.R.Senrayan, Assistant Commissioner (Commercial Taxes) (Junior) with seniority number as 16-A and the seniority number of Thiru.R.Senrayan (Junior) be re-assigned as 16-B.

5. This order is purely drawn on ad-hoc basis and it does not confer any right to the individual to claim seniority in future and it is subject to the outcome of the cases indicated in the Government Order first read above.
