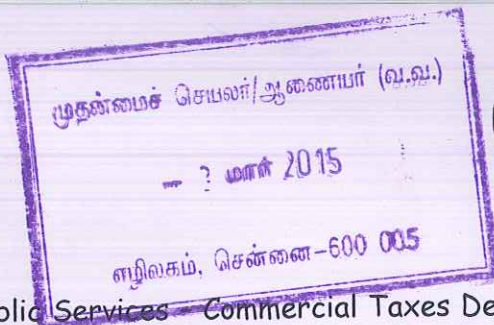

## ABSTRACT

Public Services - Commercial Taxes Department - Tamil Nadu Commercial Taxes Service - Temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioner (Commercial Taxes) by recruitment by transfer for the year 2013 - 2014 - Inclusion of the name of Tmt.G.U.Shameem Jehan, Commercial Tax Officer, Roving Squad-III, Office of the Deputy Commissioner (Commercial Taxes)(Enforcement), Central Division, Chennai - Orders - Issued.

### ORDER:-

In the Government order first read above, the Government have approved the temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners [Commercial Taxes] by recruitment by transfer for the year 2013-2014.

2. In the petition second read above, Tmt.G.U.Shameem Jehan, Commercial Tax Officer, Roving Squad-III, Office of the Deputy Commissioner (Commercial Taxes) (Enforcement) Chennai has represented for inclusion of her name in the temporary list of Commercial Tax Officers fit for appointment as Assistant Commissioners (Commercial Taxes) for the year 2013-2014, since the punishment of stoppage of increment for two years with cumulative effect imposed by the Commissioner of Commercial Taxes has been set aside by the Government in G.O. (D) No.496, Commercial Taxes and Registration (A1) Department, dated 18.9.2013 and consequently included in the list of Commercial Tax Officers for the year 2010.

3. In the letter 3<sup>rd</sup> read above, the Principal Secretary / Commissioner of Commercial Taxes has stated that Tmt.G.U.Shameem Jehan, while working as Upper Division Inspector, Puzhal Checkpost, Thiruvallur District for the imputation of misconduct/misbehavior, charge memo under rule 17(b) was issued to her in the Special



Commissioner and Commissioner of Commercial Taxes' Ref. No.E1/68805/2005, dated 29.5.2006. The above disciplinary action was finalized and she was awarded the punishment of stoppage of increment for two years with cumulative effect in Proc. dated 21.5.2009. The individual made appeal before the Government in her petition dated 6.7.2009. In G.O. (D) No.496, Commercial Taxes and Registration (A1) Department, dated 18.9.2013, the punishment of stoppage of increment for two years with cumulative effect imposed by the Commissioner of Commercial Taxes vide proceedings dated 21.5.2009 was set aside. The official has passed the Accounts Test for Executive Officers in Nov.1992 Bull No.5/ dated 16.2.1993 which is a pre-requisite qualification for the promotion as Assistant Commissioner (Commercial Taxes). Consequently, her name has been subsequently included in the list of Commercial Tax Officers for the year 2010 in the Proceedings of the Principal Secretary/Commissioner of Commercial Taxes No.P1/37060/13, dated 17.2.2014. Her services in the cadre of Commercial Tax Officer for the year 2010 commenced on 17.2.2014. However, her services in the cadre of Commercial Tax Officer as on 1.1.2013 is nil. Her date of birth is 12.12.1961 (51 years, 6 months as on 1.7.2013) and she has not crossed 57 years of age as on 1.7.2013. In view of the above, the Principal Secretary / Commissioner of Commercial Taxes has recommended that the name of Tmt.G.U.Shameem Jehan, Commercial Tax Officer (Rank No.24-A/2010 (BC) may be included in the temporary list of Assistant Commissioners (Commercial Taxes) for the year 2013 below her senior Thiru.T.Madhan Mohan (Rank No.2010/24)(OC) and above one of her junior Tmt.R.Vasanthakumari (Rank No.2010/28)(BC) vide Sl.No.158 and 159 in G.O (Ms.) No.20, Commercial Taxes and Registration Department, dated 19.2.2014, by relaxing Tamil Nadu Commercial Taxes Services Rule 4 read with Annexure 1-A(iii) relating to 2 years service as Commercial Tax Officer engaged in assessment work.

4. The proposal of the Principal Secretary / Commissioner of Commercial Taxes has been carefully examined by the Government and in view of the inclusion of the name of Tmt.G.U.Shameem Jehan in the temporary list of Commercial Tax Officer for the year 2010 and been assigned rank No.24-A and as the punishment of stoppage of increment for two years with cumulative effect imposed by the Commissioner of Commercial Taxes has been set aside by the Government in G.O.(D)No.496, Commercial Taxes and Registration (A1) Department, dated 18.9.2013, the Government hereby direct that the name of Tmt.G.U.Shameem Jehan, Commercial Tax Officer, Roving Squad-III, Office of the Deputy Commissioner (Commercial Taxes) (Enforcement) Central Division, Chennai be included in the temporary list of Commercial Tax Officers for appointment as Assistant Commissioners (Commercial Taxes) for the year 2013-2014 as approved in the Government Order first read above in relaxation of rule 4(a) read with annexure 1-A(iii) of the Special Rules for Tamil Nadu Commercial Taxes Services relating to shortage in service in all as Commercial Tax Officer engaged in assessment work in her favour. Consequent to her inclusion in the temporary list of Assistant Commissioner (Commercial Taxes) for the year 2013-2014, Tmt.G.U.Shameem Jehan is placed in between her senior Thiru.T.Madhan Mohan (OC) Sl.No.158 (Rank No.24 in the Commercial Tax Officer temporary list 2010) and her junior Tmt.R.Vasanthakumari (BC), Sl.No.159 (Rank No.28 in the Commercial Tax



Officer temporary list 2010) and assigned S.No.158A. This order is purely drawn on ad-hoc basis in accordance with the instructions issued in Government letter No.18824/S/2005-2, Personnel and Administrative Reforms (Per.S) Department, dated 7.10.2005 and this will not confer any right on the individual to claim seniority in future and the inclusion is subject to the outcome of the following cases:-

- (i) *Special Leave Petition No.CC 1762 of 2006 filed by the Government of Tamil Nadu in the issue of rule of reservation, which is pending before the Hon'ble Supreme Court of India, New Delhi;*
- (ii) *Writ Appeal No.2280 of 2011, against the orders in W.P No.11618 of 2009, W.P Nos.18847 to 18853 of 2009 and W.P Nos.21448 to 21455 of 2009 dated 6.4.2011, which is pending before the High Court of Madras;*
- (iii) *Writ Appeal Nos.155 to 159 of 2014 and MP Nos.2 of 2014 in W.A Nos.156 to 159 of 2014, against the order of the High Court of Madras dated 20.1.2014 in W.P Nos.18209 of 2012 etc. batch cases, which are pending before the High Court of Madras; and*
- (iv) *any other cases pending in this regard.*

5. The Principal Secretary / Commissioner of Commercial Taxes is requested to communicate this order to the individual concerned by Registered Post with Acknowledgement Due as ordered in G.O.(Ms) No.707, Personnel and Administrative Reforms Department, dated 3.7.1981. Necessary posting orders will be issued by the Principal Secretary / Commissioner of Commercial Taxes separately.
