Appeal) Rules have been initiated by service of charge memos or charge sheets have been filed in any criminal cases initiated against them or cases are pending before the Tribunal for Disciplinary Proceedings or punishments have been imposed, subsequent to the recommendation of their names in the Nomination Rolls by the respective Joint Commissioners(CT).

4. Objections, if any, against non-inclusion of any individual in this panel may also be addressed by the individuals through the respective Joint Commissioners to the Commissioner of Commercial Taxes within thirty days of receipt of this order.
