ORDER:-

In the Government Order first read above, orders have been issued for the realignment of the existing 89 assessment circles of the four Commercial Taxes territorial divisions of Chennai, viz., Chennai (North), Chennai (South), Chennai (Central) and Chennai (East) divisions into 100 assessment circles by retention, merger and division of the existing assessment circles and the corresponding enforcement and appellate jurisdictions based on the suggestions of the official committee constituted by the Principal Secretary / Commissioner of Commercial Taxes in this regard.

2. Consequent to the re-organization of the existing assessment circles, the territorial jurisdiction of the corresponding Commercial Tax Zones and Commercial Tax Divisions has also been rearranged by the Principal Secretary / Commissioner of Commercial Taxes in the proceedings second read above, considering the geographical contiguity of the jurisdictional area and equitable distribution of workload among the Zones and Divisions.

3. In the letter fourth read above, the Principal Secretary / Commissioner of Commercial Taxes has stated that proceedings entrusting Full Additional Charge arrangements in the newly realigned zones of the Chennai Commercial Taxes Divisions in

the cadre of Deputy Commissioner (Commercial Taxes) have been issued by him on 31.7.2014 and 1.8.2014. Similarly, the existing Appellate Deputy Commissioners (Commercial Taxes) Chennai-I, II, III & IV have been renamed as follows:-



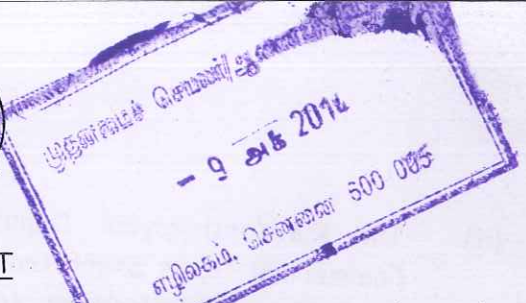

ORDER:

In the Government Order second read above, orders have been issued effecting certain transfer and postings in the cadre of Deputy Commissioner (Commercial Taxes) in the Commercial Taxes Department during the extended period of general transfers for the year 2014.

2. In the letter third read above, the Principal Secretary / Commissioner of Commercial Taxes has suggested certain modifications in the transfers of Deputy Commissioners (Commercial Taxes) as ordered in the Government Order first read above and suggested a revised proposal to Government for issue of appropriate orders.

3. As per the instructions issued in the Government letter first read above, the Government may transfer any Government servant at any point of time in public interest. The Government, after careful consideration of the proposal of the Principal Secretary/Commissioner of Commercial Taxes and the administrative reasons adduced by him for effecting such transfer, hereby orders the following transfer and postings in the cadre of Deputy Commissioner (Commercial Taxes) in the Commercial Taxes Department:-

- (i) Selvi R.Dhanupriya, Appellate Deputy Commissioner (Commercial Taxes)-VI, Chennai be transferred and posted as Appellate Deputy Commissioner (Commercial Taxes), Vellore in the existing vacancy on her request;

- (ii) Tmt K.M.Karthikeyani, Deputy Commissioner (Commercial Taxes)/ Lecturer, Commercial Taxes Staff Training Institute, Chennai be transferred and posted as Deputy Commissioner (Commercial Taxes), LTU-IV, Chennai vice Tmt A.Anbukani, Deputy Commissioner (Commercial Taxes);
- (iii) Tmt A.Anbukani, Deputy Commissioner (Commercial Taxes), LTU-IV, Chennai be transferred and posted as Deputy Commissioner (Commercial Taxes) (Revision Petition), Office of the Principal Secretary/Commissioner of Commercial Taxes, Chennai in the existing vacancy; and
- (iv) Thiru M.Ravi, Administrative Deputy Commissioner (Commercial Taxes), Trichy be transferred and posted as Deputy Commissioner (Commercial Taxes) (Legal), Office of the Principal Secretary/Commissioner of Commercial Taxes, Chennai in the existing vacancy.

3. Since the individual in Sl. No.(i) above has been posted as Appellate Deputy Commissioner (Commercial Taxes), Vellore as per her request, she is not entitled to claim TA/DA. The individual in Sl. No.(iv) above is eligible to draw TA/DA as per rules in force.

4. The Principal Secretary/Commissioner of Commercial Taxes shall send a report of compliance at the earliest.


