No. II(2)/CTR/69/2010.—In exercise of the powers conferred by sub-section 1 of Section 30 read with Section 88 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes an exemption in respect of additional tax payable by Thiruvallur Ford India Private Limited, S.P. Koil Post, Chengalpattu on the cars and components manufactured and sold by them in Tamil Nadu.

2. This Notification shall be deemed to have come into force on the 1st November 1999 and deemed to have remained in force upto and inclusive of the 31st December 2006.

BOUNDARIES

North.—Starting from the junction point of Survey Field Numbers 90-4, 91,94 and 77-3 the boundary generally runs towards east along that southern side of Survey Field Number 94. Thence the boundary turns towards south along the western side of Survey Field Number 95 and thence the boundary turns towards , east along southern side of Survey Field Numbers 95, 96 and 102 till it meets the junction point of Survey Field Numbers 102, 188 and 77-3 of 34. Mamandur Village.

East.—Thence the boundary generally runs towards south along the western side of Survey Field Number 188. Thence the boundary turns towards west along with eastern and northern side of Survey Field Number 77-4 and thence the boundary turns towards south along the western and southern side of Survey Field Number 77-4 and the western side of Survey Field Number 188 till it meet the junction point of Survey Field Numbers 188 and 77-3 of 34. Mamandur Village and Survey Field Number 90 of 36. Kuppam Village.

South.—Thence the boundary turns towards west along the northern side of Survey Field Number 90 of 36. Kuppam Village till it meets the junction point of Survey Field Number 90 of 36. Kuppam village and Survey Field numbers 77-2 and 77-3 of 34. Mamandur Village.

West.—Thence the boundary generally runs towards north along the eastern side of Survey field Number 77-2, southern and eastern side of Survey Field Number 90-4 of 34. Mamandur Village till meets the starting point.

ADMITTED RIGHTS

One cart track from patta land, Survey Field Number 90-4 of 34. Mamandur village enter the Forest Block at the cutting point of 60.2 metres from North in the 'F' line measurement of 155.2 metres of western side of Forest Block. From there the cart track passes through the Forest Block up to station 'E' and exit the Forest Block at the cutting point of 35.2 metres from North in the 'F' line measurement of 120.0 metres of eastern side of Forest Block. From station 'E' it reaches the patta lands in Survey Field Number 95-1 of 34. Mamandur Village. The length of the cart track is 157.0 metres. The width is 4.0 metres. The bearings and distances of the pathway are as detailed below:—

**Declaration of Mamandur Forest Block, Tiruttani Taluk,
Tiruvallur District as Reserved Forest under the
Tamil Nadu Forest Act.**

No. II(2)/EF/70/2010.—In exercise of the powers conferred by Section 16 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares the area, the boundaries of which are specified in the Schedule below as reserved forest with effect on and from 5th August 2010.
