### **ORDER:**

The Principal Secretary/Commissioner of Commercial Taxes in his letter read above has stated that at present Roving Squad (Checkpost) at Concor terminals has been working in Thatched Shed. Due to the growth of Industries in Chennai and also advantage of rail transport over road had increased the goods movement through concor manifold and therefore the checkpost has to be strengthened as permanent checkpost with all facilities available with that of border checkpost. Therefore the Commissioner of Commercial Taxes has requested the Government to sanction a sum of Rs.7.36 lakhs (Non-recurring) under Part-II Scheme for the year 2009-2010 for the above purpose.

2. The Standing Finance Committee has approved the proposal of the Principal Secretary/Commissioner of Commercial Taxes for the provision of cabin in the existing thatched Roving Squad (Checkpost) at Concor terminals at Enforcement-I, at a cost of Rs.7.36 lakhs (Non-recurring) under Part-II Scheme for the year 2009-2010.

3. Sanction is hereby accorded to the Principal Secretary/Commissioner of Commercial Taxes to incur an expenditure of Rs.7.36 lakhs (Rupees Seven lakhs and Thirty six thousand only) towards fixing cabin in the existing thatched Roving Squad (Checkpost) at Concor terminals at Enforcement-I, Chennai. The Principal Secretary/Commissioner of

Commercial Taxes is requested to adhere to the existing rules and norms in force while resorting to the execution of the above work.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-
