**ANNEXURE.**  
**NOTIFICATION.**

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes an exemption in respect of tax payable under the said Act by any dealer on the sale of the following goods to Tvl Swami Sivananda Centenary Charitable Hospital, Pattamadai – 627 453, Tirunelveli District, subject to the conditions that,-

*(i) the seller shall furnish a declaration duly filled in and signed by the said Hospital in the Form appended below along with the monthly return to the assessing officer;*

*(ii) the goods purchased shall be for the bonafide use of running Tvl Swami Sivananda Centenary Charitable Hospital, Pattamadai – 627 453, Tirunelveli District;*

*(iii) the hospital shall not charge more than the cost of acquisition of the products, and should not be source of profit:-*

- (i) Medicines;
- (ii) Injection;
- (iii) Surgical items;
- (iv) Laboratory items;
- (v) Medical equipments; and
- (vi) X-ray films.

2. The Notification shall be deemed to have come into force on the 1<sup>st</sup> April 2010 and shall remain in force upto and inclusive of the 31<sup>st</sup> March 2015.
