In exercise of the powers conferred by sub-section (3) of section 30 read with section 88 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes the following variations to the Commercial Taxes and Religious Endowments Department Notification No.II(1)/CTRE/70/81, published at page 10 of Part II – Section 1 of the <u>Tamil Nadu</u> <u>Government Gazette</u>, dated the 11th February 1981, as subsequently amended.

VARIATIONS.

In the said Notification,-
