ORDER:

Tvl.Bishop Sargent School for the Mentally Retarded, Palayamkottai, Tirunelveli have represented that the Government of Tamil Nadu have allotted Rs.3,05,000/- for purchase of bakery oven and flour mixing machine for imparting bakery training to mentally retarded and for their rehabilitation. Accordingly, in order to reduce the cost of the above items, they have sought for VAT exemption on the purchase of said items in the reference first read above.

2. Subsequently, in the representation 3rd read above, the petitioner has stated that they had purchased bakery oven and flour mixing machine from the following dealers by paying VAT of Rs.70,858/- and they have sought for refund of the VAT amount paid on the purchase of the said items:-

- 3. The Government, after careful examination, have decided to accept the request of the Tvl. Bishop Sargent School for the Mentally Retarded, Palayamkottai, Tirunelveli in public interest. Accordingly, Government direct that VAT amount of Rs.70,858/-(Rupees Seventy thousand eight hundred and fifty eight only) paid on the purchase of flour mixing machine and bakery oven be refunded to Tvl.Bishop Sargent School for the Mentally Retarded, Palayamkottai, Tirunelveli. The Government also authorize the Principal Secretary/Commissioner of Commercial Taxes to give necessary instructions to the Assistant Commissioner/Deputy Commissioner/Commercial Tax Officer of assessment circle concerned for issue or the refund voucher for the above amount, subject to verification of vouchers and other documents relating to payment of VAT.
- 4. The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

"0040- - Taxes on Sales, Trades etc. 102 Receipts under State Sales Tax Act - AN - Deduct refunds under State Value Added Tax Act, (1002) 02. Other Refunds under State Value Added Tax Act (DPC 0040 00 102 AN - 0204)"
