ANNEXURE. NOTIFICATION.

In exercise of the powers conferred by sub-sections (1) and (3) of section 30 read with clause (i) of sub-section (3) of section 88 of the Tamil Nadul Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby repeals the Commercial Taxes Department Notification No.II(1)/CT/#4(a)/2005, published at page 1 of Part II-Section 1 of the Tamil Nadu Government Gazette. Extraordinary, dated the 19th October 2005 and makes a reduction in rate of tax to five per cent in respect of tax payable under the said Act on the sale of LPG conversion kits for automobiles.

2. The Notification shall come into force on the 26^{th} Septémber, 2011.
