NOTIFICATION

In exercise of the powers conferred under sub-section (2) of section 8 of the Tamil Nadu Entertainments Tax Act, 1939 (Tamil Nadu Act X of 1939), the Governor of Tamil Nadu hereby exempts cinematograph film exhibited on Television Screen through Cable Television Network and television exhibition, from liability to entertainments tax payable under sections 4-D and 4-E of the said Act.

2. The Notification shall come into force with effect on and from the $1^{\rm st}$ April 2008.
