# ANNEXURE. NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes a reduction in respect of tax payable by any dealer under the said Act on the sale of Petrol with or without additives from 30 percent to 27 percent.

2. The Notification shall come into force with effect on and from the  $1^{\rm st}$  day of March 2011.
