ORDER:

The General Secretary Indo Cine Appreciation Foundation has stated that, they have proposed to organize their 10th Chennai International Film Festival from 13th to 20th December 2012 and the Venues are Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox theatre and Rani Seethai Hall of Madras. They have proposed to screen 5 shows (from 9.15 AM to 10.00 PM) at Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox theatre and Rani Seethai Hall every day from 13th to 20th December 2012. He has further stated that, there will be no sale of tickets and the entry will be based on the Delegate Cards and Special Invitations and they have been granted exemption from Entertainment Tax by the Commercial Tax Department. In addition, he has stated that, they are also

abide the conditions stipulated by the Commissioner of Police, Chennai city. He has, therefore, requested the Government to grant necessary permission to screen 5 shows (from 9.15 AM to 10.00 PM) each at Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox theatre and Rani Seethai Hall of Madras, Chennai during the 10th Chennai International Film Festival (CIFF) to be held from 13th to 20th December 2012.

2. The Principal Secretary / Commissioner of Land Administration Department, Chennai has stated that, the above said organization has furnished an undertaking that they will abide the conditions stipulated by the Commissioner of Police, Chennai city. Further, the Commissioner of Police, in his report has stated that there is no objection for conducting 10th Chennai International Film Festival (CIFF) of 5 shows (from 9.15 AM to 10.00 PM) each at Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox theatre and Rani Seethai Hall every day from 13.12.2012 to 20.12.2012 with the following conditions:-

- Show timings must be staggered such that there is sufficient time gap between closing and opening of next show.
- There should not be any hindrance to the free flow of traffic.
- The instructions of the local traffic police should be followed strictly.
- The Spectator vehicle shall not be parked on road.

The Principal Secretary and Commissioner of Land Administration, Chennai has recommended to Government to exempt Indo Cine Appreciation Foundation (ICAF) from the provisions of Rule 14-A of 'C' form licence under the powers vested in section 11 of Tamil Nadu Cinemas (Regulation) Act, 1955 for conducting 5 shows (from 9.15 AM to 10.00 PM) every day at Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox theatre and Rani Seethai Hall during the Chennai International Film Festival (CIFF) from 13.12.2012 to 20.12.2012.

3. The Government, after careful consideration, accept the request of the General Secretary of Indo Cine Appreciation Foundation, Chennai and accordingly in exercise of the powers conferred under section 11 of Tamil Nadu Cinemas (Regulation) Act, 1955, the Governor of Tamil Nadu hereby exempt the provision of conditions under Rule 14-A of 'C' form licence to the Indo Cine Appreciation Foundation for conducting 5 shows (from 9.15 AM to 10.00 PM) every day at Woodlands Theatre, Woodlands Symphony, Satyam Theatre, Casino Theatre, Inox

theatre and Rani Seethai Hall during the Chennai International Film Festival (CIFF) from 13.12.2012 to 20.12.2012, subject to the following conditions:-

- * Show timings must be staggered such that there is sufficient time gap between closing and opening of next show
- * There should not be any hindrance to the free flow of traffic
- * The instructions of the local traffic police should be followed strictly.
- * The Spectator vehicle shall not be parked on road.


