# ANNEXURE. NOTIFICATION-I.

In exercise of the powers conferred by sub-sections (1) and (3) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006) and **in supersession of** the Commercial Taxes and Registration Department Notification No.II(1)/CTR/11(b-5)/2008, published at page 3 of Part II-Section 1 of the <u>Tamil Nadu Government Gazette</u>, Extraordinary, dated the 1<sup>st</sup> April 2008, the Governor of Tamil Nadu hereby makes an **exemption** in respect of tax payable under section 12 of that Act by any dealer referred to in clause (b) of sub-section (1) of section 7 and sub-section (1) of section 8 of that Act, on the purchase of goods mentioned in **items 18, 67 and 68** of Part B of the Fourth Schedule to the said Act.

2. The Notification shall come into force on the 1<sup>st</sup> day of April 2012.

## NOTIFICATION-II.

In exercise of the powers conferred by sub-section (3) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby **cancels** the Commercial Taxes and Registration Department Notification No.II(1)/CTR/30(a-3)/2007, published at page 4 of Part II-Section 1 of the <u>Tamil Nadu Government Gazette</u>, Extraordinary, dated the 23<sup>rd</sup> March 2007.

2. The Notification shall come into force on the 1<sup>st</sup> day of April 2012.

## **NOTIFICATION-III.**

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes an **exemption** in respect of tax payable under the said Act by any dealer on the sale of the following goods, namely:-

- (i) Wheat
- (ii) Oats
- (iii) Feeding bottles and nipples
- (iv) **Helmets**
- 2. The Notification shall come into force on the 1<sup>st</sup> day of April 2012.

## **NOTIFICATION-IV.**

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes a reduction in rate of tax from 14.5 percent to 5 percent in respect of tax payable under the said Act by any dealer on the sale of sanitary towels, sanitary napkins, belt-less napkins, baby nappies and disposable diapers.

2. The Notification shall come into force on the **1**<sup>st</sup> **day of April 2012**.
