APPENDIX.**NOTIFICATION.**

In exercise of the powers conferred by section 16 of the Tamil Nadu Entertainments Tax Act, 1939 (Tamil Nadu Act X of 1939), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Entertainments Tax Rules, 1939:-

2. The amendments hereby made shall come into force on the 29th May, 2013.

AMENDMENTS.

In the said Rules, -

(1) in rule 21-G,-

(a) in sub-rule (1), after the expression **"The Indian Premier League conducting any cricket tournament"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted;

(b) in sub-rule (4), after the expression **"Indian Premier League"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted;

(c) in sub-rule (6), after the expression **"Indian Premier League conducting any cricket tournament"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted;

(d) in sub-rule (7), after the expression **"The Indian Premier League conducting any cricket tournament"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted;

(e) in sub-rule (8), after the expression **"The Indian Premier League"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted; and

(f) in sub-rule (9), after the expression **"The Indian Premier League conducting any cricket tournament"**, the expression **"or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament"** shall be inserted;

(2) in rule 30-C,-

(a) in sub-rule (1), after the expression **"any cricket tournament conducted by Indian Premier League"** occurring in three places, the expression **"or the Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted; and

(b) in sub-rule (2), after the expression **"or recreation parlour"** occurring in two places, the expression **"or any cricket tournament conducted by Indian Premier League or the Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted;

(3) in rule 43-E,-

(a) in sub-rule (1), after the expression **"any cricket tournament conducted by the Indian Premier League"**, the expression **"or the Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted; and

(b) in sub-rule (2), after the expression **"any cricket tournament conducted by the Indian Premier League"**, the expression **"or the Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted;

(4) in rule 48-A, after the expression **"the Indian Premier League"**, the expression **"or conducting the Champions League Twenty 20 cricket tournament by the Board of Control for Cricket in India"** shall be inserted;

(5) in rule 48-D, after the expression **"the Indian Premier League"**, the expression **"or conducting the Champions League Twenty 20 cricket tournament by the Board of Control for Cricket in India"** shall be inserted;

(6) in Form XVII-A,-

(a) after the expression **"any cricket tournament conducted by Indian Premier League"**, the expression **"/Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted; and

(b) in the tabular column, in the heading of first column, after the expression **"any cricket tournament conducted by Indian Premier League"**, the expression **"/Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be added;

(7) in Form XVII-B,-

(a) after the expression **"any cricket tournament conducted by Indian Premier League"**, the expression **"/Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be inserted; and

(b) in the tabular column, in the heading of first column, after the expression **"any cricket tournament conducted by Indian Premier League"**, the expression **"/Champions League Twenty 20 cricket tournament conducted by the Board of Control for Cricket in India"** shall be added.
