NOTIFICATION

In exercise of the powers conferred by sub-sections (1) and (2) of section 30 read with sub-section (4) of section 88 of the Tamil Nadu Value Added Tax Act, 2006 (Tamil Nadu Act 32 of 2006), the Governor of Tamil Nadu hereby makes a reduction in respect of tax payable by any dealer to four per cent on the sale of any goods except petrol, diesel and cement to Tvl. Power Grid Corporation of India Limited, Chennai, for use in transmission of electricity energy in the State of Tamil Nadu, subject to the condition that the dealer obtains and furnishes a certificate in the form appended to this Notification.

2. This Notification shall be deemed to have come into force on the 27th March 2002.
