ORDER:

The Commissioner of Commercial Taxes has sent proposals for re-designation of posts in the Commercial Taxes Department from the cadre of Deputy Commercial Tax Officer to the cadre of Joint Commissioner, based on the resolution passed by the Tamil Nadu Commercial Tax Officers' Association and with a view to place the Commercial Taxes Officials on par with the equivalent posts in other Departments in the State carrying similar basic pay.

2. The Government carefully examined the proposal of the Commissioner of Commercial Taxes and have decided to accept it. Accordingly, they order that the posts in the Tamil Nadu Commercial Taxes State and Subordinate services in Commercial Taxes Department be re-designated as indicated against each post as follows:-

They further order that the above re-designation will not confer any rights to the incumbents for revision in the scale of pay of the respective posts.

3. Necessary amendments to the relevant Special Rules for Tamil Nadu Commercial Taxes Services and Tamil Nadu Commercial Taxes Subordinate Services will be issued separately.
