ORDER:

Based on the announcement made by the Hon'ble Minister for Commercial Taxes while moving the demand on the floor of the Assembly for the year 2007-2008, the Commissioner of Commercial Taxes has sent proposal to Government as detailed below:-

"In order to effective implement the e-Governance initiatives in the Commercial Taxes Department in serving mercantile public, electronic services like e-filing of returns, e-remittance of tax and e-assessment through websites and online issue of statutory forms are to be made available. In view of that the following items have to be procured'.

2. The Commissioner of Commercial Taxes has requested the Government to accord sanction of funds of Rs.454.75 lakhs (Rupees Four fifty four lakhs and Seventy five thousand only) and to authorise him to purchase Computers and related items in the

savings if occurs due to reduction of cost in executing the above said work at the time of execution.

- 3. The Government have examined the proposal and decided to sanction an amount of Rs.454.75 lakhs (Rupees four hundred fifty four lakhs and seventy five thousand only) to implement e-Governance initiatives in the Commercial Taxes Department as detailed below, subject to the condition that the final price discovery of Wet-lease should be done through a transparent tender process. The Commissioner of Commercial Taxes to incur the expenditure for the above said items and also to purchase computers and related items in the savings, if occurs, due to reduction of cost in executing the above said work at the time of execution.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

- 5. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2007-08 pending provision of funds. The Commissioner of Commercial Taxes is requested to draw and disburse the above expenditure.
- 6. The expenditure should be brought to the notice of the legislature by specific inclusion in the supplementary estimate 2007-2008. The Commissioner of Commercial Taxes may be requested to send necessary proposal for inclusion of the expenditure in the supplementary estimate to Finance (BG-I) at the appropriate stage.
- 7. This orders issues with the concurrence of Finance Department vide its U.O. No.8853 (Revenue) 2008, dated 19.2.2008 and ASL No.1871 (One thousand eight hundred and seventy one).
