### **ORDER:**

Based on the announcement made by the Hon'ble Minister for Commercial Taxes while moving the demand on the floor of the Assembly for the year 2007-2008, the Commissioner of Commercial Taxes has sent proposal to Government as detailed below:-

Presently the computers in unit offices is being connected to the servers in the Central Computer Centre through PSTN line of the unit offices and the PRI lines of the respective Divisions which often has the problems of not getting connected or retaining the connection for a reasonable period of time. In order to overcome the present problem, it is suggested that the leased line connectivity from the unit offices to the server in the Central Computer Centre is very much essential and it has to be established either through TNSWAN or by obtaining the leased lines. In order to effectively implement the above under VAT environment, an amount of Rs.2.10 crores has been proposed for the procurement network hardware related to TNSWAN connectivity to the Commercial Taxes Department.

2. The Commissioner of Commercial Taxes has requested the Government to accord sanction of funds for Rs.210 lakhs and to authorize him to incur the above expenditure through ELCOT.

3. The Government have examined the proposal and decided to accord sanction for Rs.154.77 lakhs instead of Rs.210 lakhs. The Government accordingly sanction a sum of Rs.154.77 lakhs. (Rupees One hundred Fifty four lakhs and Seventy seven thousand only) for the procurement of Network, Hardware related to TNSWAN connectivity and also to authorize the Commissioner of Commercial Taxes to incur the above expenditure through ELCOT.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

5. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2007-08 pending provision of funds. The Commissioner of Commercial Taxes is requested to draw and disburse the above expenditure.

6. The expenditure should be brought to the notice of the legislature by specific inclusion in the supplementary estimate 2007-2008. The Commissioner of Commercial Taxes may be requested to send necessary proposal for inclusion of the expenditure in the supplementary estimate to Finance (BG-I) at the appropriate stage.
