ORDER:

Based on the announcement made by the Hon'ble Minister for Commercial Taxes while moving the demand on the floor of the Assembly for the year 2007-2008, the Commissioner of Commercial Taxes has sent proposal to Government as detailed below:-

In view of the total computerization of the department with application packages having numerous options and uses, the Officers and the staff of the department require to be satisfactorily trained. Besides, at the cutting edge of the department, the staff and the others do basically need to be trained in the computer in areas like word processing, spreadsheet, presentation and database software. Since it is envisaged to provide computers to all the staff in the department, training them in the Office packages is indispensable. The details of the strength of the Officers and staff are tabulated below:

2. The Commissioner of Commercial Taxes has therefore requested the Government to accord sanction of funds for Rs.213.66 lakhs and also to authorize him to occur an expenditure for the above said training through ELCOT.

3. The Government have examined the proposal and decided to sanction an amount of Rs.210 lakhs (Rupees Two hundred ten lakhs only) for conducting training to 7000 staff of Commercial Taxes Department at the cost of Rs.3000/- per participants as per the following structure of training:-

- i) Linux and its application package : 2 days
- ii) Windows and its application package: 1 day
- iii) Commercial Tax application package: 2 days

This may be treated as “New Instruments” of Service and to authorize the Commissioner of Commercial Taxes to incur the above expenditure for the above said training through ELCOT.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

2040 00 Taxes on Sales, Trade etc. 001 Direction and Administration – Schemes in the Eleventh Five Year Plan – II State Plan – JB Special Initiatives e-Governance in Commercial Taxes Department – 76 Computer and Accessories – 01 – Purchase (DPC. 2040 00 001 JB 7615).

5. Necessary funds will be provided in Revised Estimate/Final Modified Appropriation 2007-08 pending provision of funds. The Commissioner of Commercial Taxes is requested to draw and disburse the above expenditure.

6. The expenditure should be brought to the notice of the legislature by specific inclusion in the supplementary estimate 2007-08. The Commissioner of Commercial Taxes may be requested to send necessary proposal for inclusion of the expenditure in the supplementary estimate to Finance (BG-I) at the appropriate stage.

7. This orders issues with the concurrence of Finance Department vide its U.O. No.8862/Finance (Revenue)2008 dated 19.2.2008 ASL No.1873 (One thousand eight hundred and seventy three).
