







Cinemas - Tamil Nadu Cinemas (Regulation) Rules, 1957 –Permission to conduct an extra show during "Deepavali Festival Week-2013" in the theatres all over Tamil Nadu - Orders - Issued.

From the General Secretary, Tamil Nadu Film Exhibitors' Association, Chennai–18, letter Ref. No.11/19/2013-2014, dated; 04.10.2013.

ORDER:

In the letter read above, the General Secretary, Tamil Nadu Film Exhibitors' Association, Chennai has stated that, the Government grants permission to the Cinema Theatres in Tamil Nadu to conduct an extra show during "Deepavali Festival Week" every year in response to their representation. In view of the ensuing Deepavali festival, he has requested the Government to grant permission for conducting an extra show on 04.11.2013, 05.11.2013, 06.11.2013, 07.11.2013 and 08.11.2013 at 9.00 a.m. for all permanent and semi-permanent theatres in Tamil Nadu, after due intimation to the Licensing Authorities as well as the concerned Commercial Tax Authorities. He has also stated that, the cinema theatres are already having the permission for extra show on 02.11.2013 (i.e) Deepavali Day and also on 03.11.2013 (i.e) Sunday since, they happen to be Public Holidays. As far as Touring Cinema Theatres in Tamil Nadu are concerned, he has requested that, an additional show may be permitted on 02.11.2013 and 03.11.2013 as morning show at 11.30 a.m. and on 04.11.2013, 05.11.2013, 06.11.2013, 07.11.2013 and 08.11.2013 as matinee show at 2.30 p.m.

- 2. The Government after careful consideration, accept the request of the General Secretary, Tamil Nadu Film Exhibitors' Association, Chennai in para-1 above.
- 3. In exercise of the powers conferred under section 11 of the Tamil Nadu Cinemas (Regulation) Act, 1955, the Governor of Tamil Nadu hereby exempts the licensees of the permanent and semi-permanent cinema theatres from the provision of condition 14-A of the "C" form licence prescribed under the Tamil Nadu Cinemas (Regulation) Rules, 1957 and permit the permanent and semi permanent theatres in Tamil Nadu to conduct an extra show from 04.11.2013 to 08.11.2013 (5 days) in connection with the Deepavali Festival Week subject to the condition that, the licensees should intimate the Licensing Authorities and also the concerned Commercial Tax

Officers having jurisdiction over the place of exhibition in advance. As the Deepavali day happens to be a public holiday, the permanent and semi-permanent theatres have permission for an extra show on 02.11.2013 (Deepavali day) and 03.11.2013 (Sunday). The Government also permit the Touring Cinema Theatres in Tamil Nadu to conduct an additional show on 02.11.2013 and 03.11.2013 as morning show at 11.30 a.m. and from 04.11.2013 to 08.11.2013 (5 days) as matinee show at 2.30 p.m. after intimating the Licensing Authorities and the Commercial Tax Officers concerned.
